1. Prayer and Reflection (Diane Bradac)

2. Addressing the Pastoral Council

Betsy Root: Hearing-impaired devices no longer work in the Mass. Ann-Marie has done a lot of work to help, but still not working. Sherry will be looking into this tomorrow.

Jennifer Karius: Interested in participating in the council. Mass—open three doors rather than just one, could help to limit germs. Weekday morning is not her time, would prefer a 5 PM weekday Mass. Discussion about number of doors, increased air circulation, how to control numbers with more than one door. Fr Joe: Looking for a different Mass time? Jennifer: Would prefer multiple doors, reduces contact with sign in sheets/pens. Fr. Joe: We are following the CDC and Health Dept policy. Jennifer: Is this underlying principle? Fr. Joe: Yes. Mary C.: Sign in on-line? Fr. Joe: We are resisting this. Sue H.: voluntary online sign in? Intense discussion over the logistics of multiple doors and multiple vs remote sign-ins.

3. October Minutes

Any questions or corrections? None. Minutes approved.

4. Sustainability discussion Mike Redlin and Scott Doyle

Presentation notes: appended. Requesting approval for further investigation (2a). Yes by acclamation. Item 2b: One meter in the church combining all energy. Originally two meters but one removed. This was not reported to ESCO. May affect the rate. Gas: now NYSEG, but ESCO might provide it more cheaply. Fr. Joe—we don't know if it will be cheaper. Mike—we'll have to check and see. This will be referred to Kathleen (finance).

Item 3- in addition to original proposal. 3a Energy audit on any building. Council approves doing it on all three. 3b. LED lights. May not lower carbon footprint but would save money. Initial installation cost. But relamping lights in Church require a lift and cost thousands of dollars to do—every three months. Council agrees that they should go look at cost of LED which would require a much less frequent installation. (\$ 174,000 is current estimate for relamping church Up to the finance council.)

Phone ministry Thanks to Diane. Everyone has their two pages.

Mary C got several people, appreciate live streaming. Most people trying to stay safe and in their own family pod. No one asked to be called back.

Mary Kay L had a discussion with one parishioner who has an issue with leaving husband alone. Discussion of whether "Martha's ministry" could help. People watching online. Several people wish the 5 PM weekday Mass could be reinstituted. Fr. Joe does not object to reinstituting it. 9 AM difficult for many people. Fr. Joe will reinstitute a 5 PM once per week.

Fr. Joe: Keeping a phone log of what happened is very useful. Two concerns: falling way behind on collections: \$7K short for two weeks each, then \$5K short this week Not sustainable. If continues would have to cut one staff member.

One hospitality minister served this week had been in contact with someone who tested positive. If the minister doesn't show any symptoms by end of today, then no need to quarantine. If St. Cath has to close (to be determined by health dept), then can't even live stream. Come to Jesus moment Emphasizes how important it is to control—single doors, masks, etc. Exposure issue is length of time issue. Bulletin there will be a warning that if someone has been exposed, don't come to church!

Promote Thanksgiving dinner, please.

Question about Thanksgiving dinner at Sanctuary church. No one knows, but St. Catherine is providing groceries on its usual week. Mary Crosley will find out about Thanksgiving. (Update 11/14: Mary determined that they prefer Christmas be a special meal, not Thanksgiving).

<u>Response to the parishioners</u>: Betsy—someone will circle back.

Jennifer—5 PM Mass will be offered. Touchless sign in—have greeter sign in for them. Steve Jesch will reach out to Jennifer.

Diane: When parishioners come in, listen, engage but don't feel obligated to give the answers right then.

Presentation to Pastoral Council November 11, 2020

On September 14, 2020, the Pastoral Council approved the Sustainability Committee's proposal for "Framework Toward Carbon Neutrality".

Scope: Determine current <u>carbon footprint</u> from use of electricity and natural gas for all buildings on St. Catherine's campus and make recommendations for decreasing the carbon footprint from those buildings through cost effective investments.

Tonight, the Committee presents its Recommended Immediate Actions and asks for the PC's approval.

Recommended Immediate Actions:

- 1. <u>Determine baseline utility consumption and carbon footprint of campus</u> buildings by utilizing obtained NYSEG data.
 - a. The baseline utility consumption and its cost are shown on page 2&3.
 - b. Develop the carbon footprint from the baseline consumption.
- 2. <u>Investigate added opportunities for switching electricity to clean, renewable sources which cost no more than the current costs.</u>
 - a. Investigate completing the solar panel project on the parish center. Based on preliminary information, this would reduce the amount of dirty electricity used, and the investment is viable over 15 years.
 - b. Pursue with ESCO the dropped meter issue and adding gas in the church.
- 3. Added actions saving energy and likely being a viable investment.
 - a. Commission an energy audit on the rectory with NYSERDA support. Effective July 13, 2020 through December 31, 2020, Green Jobs Green New York Energy, such studies will be available at no cost for eligible customers (non-profits of any size).
 - b. Investigate refitting church building with LEDs. This would save on consumption but may not lower carbon footprint because electricity to church is already generated by an ESCO oriented towards solar.
