From the Pastor

Our Gospel passage is part of the farewell discourse of Jesus, as he prepares his disciples for his crucifixion and departure. More specifically, it is part of a prayer in which Jesus prays for his disciples, who will be left in the world without his physical presence.

The intercessory prayer of Jesus in John 17:11b-19 is a prayer for the disciples' protection, but it involves several specific elements. First, there is a specific concern for the disciples' unity.

Second, the prayer specifies two reasons why protection is needed for the disciples; (1) "the evil one" and the presence of hate rob the disciples of a sense of belonging in this world and (2) the disciples are sent into this world just as Jesus has been sent because the world is the object of God's ongoing love and mission.

Third, there is a specific request for God to set the disciples apart: namely, their sanctification in truth, which is equated with God's Word. Earlier in the prayer, Jesus has stated that he has already given to his disciples the word that he has received from God, so we know that the truth is none other than Jesus' word and, according to John 14:6, Jesus himself. After all, the Word has "the words of eternal life". Since the two references to sanctification enclose the sending of the disciples in God's mission of love, their sanctification does not mean their isolation or quarantine from the world, but rather, their loyalty to Jesus and to God.
