Some Words from the Pastor:

Happy Third Sunday of Easter! Today we hear about another moment when Jesus appears to His disciples after the Resurrection. Throughout these appearances, Jesus is teaching His disciples to understand the significance of His triumph over death, and to take this good news out to the world.

The Mass is really the most wonderful time we have to reflect on the stories of Scripture. At Mass, Jesus not only speaks to us as a whole community, but He also wants to speak to the heart of each one of us individually. Am I listening knowing that Christ is speaking to me directly, in a way that applies to my life today?

Sometimes it is difficult to do this. Maybe I can't understand what the lector is saying. Or maybe the wording of Scripture is hard to understand. I highly suggest that you have a practice of reading the readings before Mass starts. This helps! There are many different books out there that have the readings. There are also apps for your phone like iBreviary. I use the bishops' website, USCCB.org for the readings of Mass. Whatever you use, this great practice will really prepare your ears to receive what Jesus wants to say to you today.

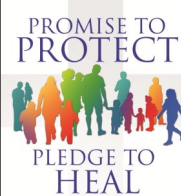
