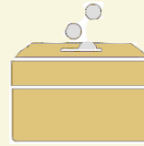

## SAPPHIRA THE LIAR

There is no other vivid story in the book of Acts as that of Ananias and Sapphira. It happened in the honeymoon period the Church. Apostles were held with extraordinary respect. The expectation of the members was equally high.

Ananias and Sapphira were couples. In the family they took decisions consulting each other. They wanted to join the new Jesus movement under the leadership of Peter. They knew that those who wanted to be a part of the group had to surrender all the material possessions at the feet of the Apostles for the common good of the community. But Scripture says, "Now a man named Ananias, together with his wife Sapphira, also sold a piece of property. **With his wife's full knowledge** he kept back part of the money for himself, but brought the rest and put it at the Apostles' feet." But as the report shows it cost them their own lives.

They owned the land. No one asked them to sell it, and no one demanded their money. They had seen the example of Barnabas and others, who showed utter honesty with regard to their property (Acts 4:37); but unlike Barnabas, they did not trust the providence of God. They held back an amount for themselves, a security, and worse, they claimed what they were giving the full amount. They thought they could serve both God and themselves. Both died instantly as they told Peter their fabricated story. Peter's reaction is a condemnation of the hypocrisy.

Sapphira seems to be more culpable. By using her clout in the family she could try to dissuade Ananias from the decision making. She never tried. Peter reminded her of what happened to her husband. He asked, "Why did **you** agree to test the Spirit of the Lord" (Acts 5: 2). This question intimates that she could have made a difference in Ananias' behavior. She could immediately tell the truth and escape death too. She did not make use of the given opportunity. Even in sinning and death they were together!

Selfishness and deceit are in contradiction to the Spirit. It is a sin against the Holy Spirit.
