School administration must be provided this form a minimum of 24 hours prior to the event. Forms provided the same day of the event are subject to being denied. For travel that includes travel from the event back to Bismarck, students must have the signed form printed out and in their possession so the head coach/advisor can verify the adult designated above is authorized to provide transportation. If the student forgets the form, the student may not be released to travel.

## Assumption Of Risk & Release Of Liability

I have made the decision to allow My Student\* to travel to or from a School Related Activity\*\* with a person who is not My Student's parent or guardian. I have full knowledge and appreciation of the risks of allowing My Student to travel with an adult other than a parent/guardian, but I nevertheless assume the risks of my decision. I agree Light of Christ, its officers, administrators, directors, employees, volunteers, agents, and insurers (collectively, "Light of Christ") shall not be liable for and I fully and freely assume the risk of any injury, loss, damage, or death relating to or arising out of My Student traveling to or from any School Related Event by means of travel other than School-provided transportation. This waiver of liability and assumption of risk for which I assume full liability and responsibility includes any and all claims, demands, injuries, damages, lawsuits, subrogation claims, third party claims, and/or causes of action (collectively, "Claims"), whether by me, my spouse, family members, any child, children, heirs, assigns or any other person or party, arising out of or connected with My Student traveling by means other than that provided by the School, and I expressly and forever release and discharge Light of Christ from any and all such Claims. I further hold harmless and agree to defend and indemnify Light of Christ to the fullest extent of the law from and against any such Claims.

**\*My Student** means the Light of Christ student(s) for which the parent or guardian of the student is requesting alternative travel arrangements from anyone other than a parent or guardian.

**\*\*School Related Activity** means any school sponsored co-curricular, co-op co-curricular, club, organization, group, meeting or event.
