



## National School Lunch Program/School Breakfast Program

Dear Parent/Guardian,

The enclosed packet includes the 2023-2024 Free and Reduced Price Meals Family Application used to apply for meal benefits for your children. While the information packet includes pricing for meals if your children are approved at a reduced price level, the signed Ohio Budget bill includes a provision for the State to cover the cost for the reduced price breakfast and lunch. Students will continue to be approved and meals counted at the reduced price benefit level, however, the reduced price meals will be at no charge to the students.

For the 2023-24 school year, the price of reduced and paid lunches will be as follows:

## Frequently Asked Questions About Free and Reduced-Price School Meals

Dear Parent/Guardian:

Children need healthy meals to learn. The Catholic Diocese of Cleveland/Nutrition Services offers healthy meals each school day. Breakfast costs \$1.75; lunch costs \$3.00. Your children may qualify for free meals or for reduced-price meals. Reduced price is \$.30 for breakfast and \$.40 for lunch. This packet includes an application for free or reduced-price meal benefits and detailed instructions. We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to the school. Below are some common questions and answers to help you with the application process.

**STOP!** If you have received a NOTICE OF DIRECT CERTIFICATION for free meals, do not complete the application. But do let the school know if any children in your household are not listed on the Notice of Direct Certification letter you received.

- 1. Who can receive free or reduced-price meals?** All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP), or Ohio Works First (OWF); foster children that are under the legal responsibility of a foster care agency or court; children participating in their school's Head Start program; and children who meet the definition of homeless, runaway, or migrant are eligible for free meals. Also, your children may receive free or reduced-price meals if your household's income is within the federal income eligibility guidelines limits.
- 2. How do I know my children qualify as homeless, migrant or runaway?** If members of your household lack a permanent address; are staying together in a shelter, hotel or other temporary housing arrangement; relocate on a seasonal basis or; children live with you who have chosen to leave their prior family or household then the children may qualify as homeless, migrant or runaway. If you have not been told your children will receive free meals, please call the **Catholic Diocese of Cleveland/Nutrition Services (216) 696-6525 Ext. 6320** to see if they qualify.
- 3. Do I need to fill out an application for each child?** No. Use one free and reduced-price school meal application for all students in your household.
- 4. Should I fill out an application if I received a letter this school year saying my children are already approved for free meals?** No, but please read the letter carefully and follow the instructions. Please call **Catholic Diocese of Cleveland/Nutrition Services (216) 696-6525 Ext. 3120** if any children in your household were missing from your eligibility notification or if you have questions.
- 5. My child's application was approved last year. Do I need to fill out another one?** Yes. Your child's application is valid for that school year and for the start of this school year. You are required to submit a new application unless you have already received a letter telling you that your child is eligible for the new school year. Otherwise your child will be charged the full price for meals.
- 6. I receive Women, Infants and Children (WIC) benefits. Can my child(ren) get free meals?** Children in households participating in WIC may be eligible for free or reduced-price meals. Please submit a completed application.
- 7. Will the information I give be checked?** Yes, we also may ask you to send written proof of the household income you report.
- 8. If I don't qualify now, may I apply again later?** Yes. You may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free or reduced price meals if the household income drops below the income limit.
- 9. What if I disagree with the school's decision about my application?** You should talk to Nutrition Services' officials. You may also ask for a hearing by calling or writing to: **Karen McKittrick, Catholic Diocese of Cleveland/Nutrition Services, 1404 East Ninth Street, 2<sup>nd</sup> Floor, Cleveland, OH 44114-1722 (216) 696-6525 Ext. 6320.**
- 10. May I apply if someone in my household is not a U.S. citizen?** Yes. You or your child(ren) do not have to be U. S. citizens to apply for free or reduced-price meals.
- 11. What if my income is not always the same?** List the amount that you normally receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down the routine amount of \$1000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 12. What if some household members have no income to report?** Household members may not receive some types of income that are asked for you to report on the application or may not receive income at all. When this happens, please write a 0 in the corresponding field or check the No Income box. However, if any income fields are left empty or blank, those also will be counted as zeros. Please be careful when leaving income fields blank.
- 3. We are in the military, do we report our income differently?** Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it must also be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
- 4. What if there is not enough space on the application for my family?** List any additional household members on a separate piece of paper and attach it to your application. Contact the school to receive a second application if needed.
- 5. My family needs more help. Are there other programs we might apply for?** To find out how to apply for Ohio SNAP or other assistance benefits, contact your local assistance office or call 877-852-0010.

**Privacy Act Statement: This explains how we will use the information you give us.**

The Richard B. Russell National School Lunch Act requires the information on this application. You are not required to provide information, but if information is not provided, the state agency cannot approve your child for free or reduced-price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Ohio Works First (OWF) case number or other identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced-price meals, and for administration and enforcement of the lunch and breakfast programs. We may share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.
