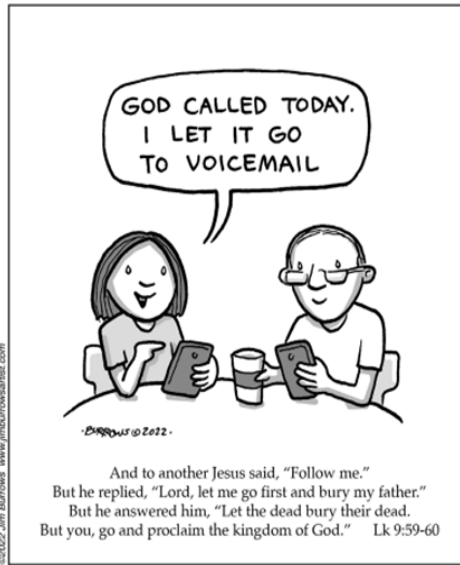
### Summer Camps with Mrs. B and Mrs. Burch
