Nature of Risks (Youth)

I acknowledge that my child may be exposed to health risks such as COVID-19, H1N1, and similar infectious illnesses as they are inherent in any location where people are present. NFCYM cannot guarantee that my child will not be exposed to such health risks. People who show no symptoms can spread illness if infected, and any interaction with the public poses an elevated risk of being exposed to illness. By allowing my child to come to NCYC, I understand and agree to assume these inherent risks. If my child experiences symptoms of illness while at NCYC, s/he may be required to leave Facilities—the cost of testing, isolation/quarantine, care, and transportation remain my responsibility.

Consent to Search, Record, and Contact (Youth)

I consent in advance to a reasonable search of my child's person and personal carry-in items by NFCYM, the Facilities, or law enforcement officials as deemed necessary for security purposes.

I am also waiving any right to monetary recovery on Our Behalf.
