CALENDAR ADVISORIES FOR 2026

December 7-8, 2025

Even though the Solemnity of the Immaculate Conception of the Blessed Virgin Mary falls on a Monday, it retains its obligation. Therefore, there are back-to-back obligations with Sunday. One should fulfill both obligations by assisting at two Masses, one for each of the two days (the Sunday evening Mass may "count" for either but not both). Ritual and funeral Masses are not permitted. A marriage or funeral may be celebrated outside of Mass using the texts from the Rite of Marriage or the Order of Christian Funerals. On the night of Sunday, December 7, EP II for the 2nd Sunday of Advent is celebrated, as is the Mass for that Advent Sunday.

December 24-25

For prayers, the Missal has five different Masses for Christmas Eve and Christmas Day. The Mass for December 24 is the proper text for Masses in the morning of December 24. The proper text for Masses in the evening (= after 4 p.m.) of December 24 is the Christmas – Vigil Mass. The texts for Christmas – Mass during the Night are to be used for Masses beginning "at night," preferably on or around midnight between December 24 and 25. The proper texts for the first Mass in the morning of December 25 are those for Christmas – Mass at Dawn. Later Masses on December 25 should use the texts for Christmas – Mass during the Day.

The Mass during the Night may be preceded by a more prolonged vigil, taken from the Office of Readings (see the General Instruction of the Liturgy of the Hours #71-73, 98, 215). This extended vigil is the preferred time for the blessing of the crèche (Book of Blessings, ch. 48, §1542-44).

The <u>Lectionary for Mass</u> provides 4 sets of readings for Christmas: the Vigil, the Mass at Night, the Mass at Dawn, and the Mass during the Day. It is strongly recommended that the readings be used as assigned, in particular that the Vigil readings be used at the Vigil. That being said, based on pastoral need, and acknowledging that the Mass that any person attends will be "their" Christmas Mass, the *Homiletic Directory* (#110) allows for the use of any of the 4 sets of readings at any of the four Masses.

On December 25, Ritual Masses (i.e., marriage, confirmation) and funeral Masses are prohibited. A marriage or funeral may be celebrated outside of Mass using the texts from the Order of Celebrating Matrimony or the Order of Christian Funerals.

May 25

This new obligatory Memorial of the Blessed Virgin Mary, Mother of the Church, is celebrated every year on the Monday after Pentecost. Please see https://www.usccb.org/prayer-and-worship/liturgical-year-and-calendar/mother-of-the-church for the Mass texts.

June 28-29

The Solemnity of SS. Peter and Paul falls on Monday, June 29. It is therefore not a holy day of obligation, and so may not be anticipated. Funeral Masses are permitted, but ritual Masses (such as weddings) are not. If we lived in a country where Ss. Peter and Paul were a day of precept, the Vigil Mass of Ss Peter and Paul would have precedence on Sunday evening. However, we do not, so the Sunday Mass, which is of precept takes precedence.

August 15

Because it falls on a Saturday, the Solemnity of the Assumption of the BVM is NOT a Holy Day of Obligation this year. Because the obligation is lifted, funeral masses are permitted. However, ritual Masses (i.e., marriage, confirmation) are not. A marriage may be celebrated outside of Mass using the texts from the Order of Celebrating Matrimony.

A marriage or funeral may be celebrated outside of Mass using the texts from the Order of Celebrating Matrimony and Order of Christian Funerals, respectively.

A NOTE ON PARTICULAR CALENDARS

Please refer to the "Table of Liturgical Days According to Their Order of Precedence" (reproduced on page 7) and the *Norms Governing Liturgical Calendars* for details.

Parishes are also reminded that the Anniversary of Dedication of their church and the title of their church are celebrated as Solemnities for that community. Because these outrank Sundays in Ordinary Time, those celebrations can be moved to the Sunday of the week they fall in as long as we are in Ordinary Time (*Norms Governing Liturgical Calendars*, § 58).

The feast of the principal patron of the diocese and the anniversary of the dedication of the cathedral are also to be observed. For the Diocese of Davenport, the Feast of the Anniversary of the Dedication of the Cathedral is observed on November 15 (of course, at the Cathedral itself it is observed as a Solemnity—and may be transferred to the preceding Sunday). The diocese has no patron.

*Because November 15 falls on a Sunday this year, the Sunday takes precedence (except at the Cathedral itself), and so the feast is not observed in the rest of the diocese.

In addition, the *Ceremonial of Bishops* states that the anniversary of the bishop's episcopal ordination should be celebrated in each church. The Mass for Various Needs and Occasions, I. For the Church, 3. For the Bishop is used – except on days listed in #'s 1-6 on the Table (§ 1167). Bishop Walsh's Anniversary of Ordination is September 27.

*Therefore, because September 27 falls on a Sunday this year, the Sunday Mass is to be used. It would be appropriate to remember the bishop in the universal prayer.

The *Ceremonial* also states that each year the anniversary of the last *deceased* bishop be observed, unless he had been transferred to another diocese (§ 1168). In our case, that would be Bishop O'Keefe, whose anniversary of episcopal ordination is July 2.

A NOTE ON THE OBLIGATION TO ATTEND MASS ON SUNDAYS AND HOLY DAYS

The obligation to attend Mass applies to the day, not the Mass being celebrated or the texts used. For Sundays and Solemnities, the observation of the liturgical day runs from 4:00 p.m. of the calendar day before to midnight of the day itself – a period of 32 hours.

For example, attendance at a Wedding Mass after 4 p.m. on Saturday would fulfill the Sunday obligation. Likewise, if a parish celebrated the Ritual Mass of Confirmation on Sunday, the obligation would be fulfilled. Please recall that Ritual Masses are not permitted on the Sundays of Advent, Lent, and Eastertime.

Only in the case of Christmas and the Immaculate Conception would a Holy Day of Obligation fall on a Saturday or Monday and create back-to-back obligations with Sunday. One should fulfill both obligations by assisting at two Masses, one for each of the two days. Situations arise, of course, in which fulfilling Mass obligations on consecutive days is either impractical or impossible for an individual or a family. The Church allows parish pastors to "grant in individual cases a dispensation from the obligation of observing a feast day or a day of penance or can grant a commutation of the obligation into other pious works" for a just cause and subject to any regulations laid down by the Diocesan Bishop (canon 1245; see canon 87 §1). Members of the Catholic faithful who can only attend one Mass to fulfill their obligations (whether that of Sunday or of the holy day) should speak with their pastor to seek alternate accommodations.

History

Since the Second Vatican Council, the celebration of ember and rogation days continue to exist as ways for the Church "to entreat the Lord for the various needs of humanity" (*Universal Norms on the Liturgical Year and the Calendar*, no. 45), though the scheduling of such days was delegated to Conferences of Bishops. In the United States, that authority rests with each Diocesan Bishop (see *General Instruction of the Roman Missal* [GIRM], no. 373), as they are better able to discern what special intentions need to be prayed for in the respective dioceses and regions. Even as each diocese maintains its list of such special observances, the terminology of ember days and rogation days has shifted to that of "Days of Prayer." The Holy See has also recommended to the universal Church a number of such days, often termed "World Days of Prayer" and frequently promoted by Popes. The USCCB and its committees have offered additional special observances for the United States.

Liturgical Considerations

No liturgical texts or requirements are attached to these observances with the exception of the U.S. day of prayer each January 22. However, these important commemorations can certainly be noted in the homily and universal prayer at Mass, and through other community events. Optionally, some of the special observances can be emphasized by drawing from the Masses and Prayers for Various Needs and Occasions in the *Roman Missal*, but those that fall on Sundays of Ordinary Time would require the permission of the Diocesan Bishop for an appropriate Mass (see GIRM, no. 374). On days where an observance coincides with an Optional Memorial or a weekday in Ordinary Time, a celebrant would be free to select a fitting Mass (see GIRM, no. 377), although consideration must be given to the fact that many Days of Prayer are scheduled on days when the daily liturgy is quite appropriate (i.e., World Day of the Sick on the feast of Our Lady of Lourdes, World Day of Prayer and Awareness against Human Trafficking on the feast of St. Josephine Bakhita, etc.).
