
Dear Parishioners,

It is very hard to believe we are moving into the fall season. The summer flew by. This certainly has been a very eventful year in our world. Amidst the seemingly crazy world we live in, I take such solace in being able to pastor two great parish communities. I always find such joy here. Even my toughest days are still filled with blessings. One of the reasons I can say this is because parishioners are so generous with their time, talent, and treasure. People here give so freely and generously, instilling a real sense of love and vibrancy. We are Blessed!

As a pastor I wear many hats. My favorite, of course, is presider at Mass when we celebrate the Word and the gift of the Body and Blood of Christ. While I prefer the titles pastor and shepherd, the reality is that in many ways I am the CEO of both parishes. One of my duties under that title is to produce an ANNUAL REPORT of the finances and affairs of the parish.



I share with you the results of the 2022—2023 fiscal year for St. John of the Cross. As you can see we finished the year in the "red" with a loss of just over \$6,700. Most of this has to do with the fact that our income is down. We were able to lower expenses, but still not enough to break even. We will work hard to control of our expenses and I am asking that you consider increasing your offering a bit. If you give \$20 a week, consider giving \$25 week. Every few dollars helps. We run a fairly lean operation and will continue to do so. We do have some savings but we want to keep those for future endeavors.

One of the things I would like to bring to your attention:

If you are aged 70½ or older, you again have the opportunity to save on taxes and make a charitable distribution gift from your IRA. With a direct transfer from your traditional IRA to a qualified charity, you satisfy your minimum required distribution for the year. IRA Qualified Charitable Distributions are income tax-free so long as the gift is made by December 31st. IRA Qualified Charitable Distributions- Fast Facts

- •• You must be 70 ½ and older
- •• Distributions must be made directly from the IRA to a qualified charity
- •• Your taxable income can be reduced by up to \$100,000, the maximum allowable
- •• Only traditional IRA accounts are eligible. The IRA Qualified Charitable Distribution cannot be used with other retirement plans such as a 401(k), 403(b) or a SEP IRA





LUKE BROWN REFLECTIONS

Serving Others (Part 1 of 3)

When it comes to serving others, I am reminded of a parable. The parable starts with an image of Hell where there is an enormous banquet of delicious food and everyone present is ravenous. Everyone has utensils attached to their hands that are three feet long and so they cannot scoop the food into their own mouths. Consequently, everyone remains hungry. Heaven is the same thing, except everyone is feeding the people around them. Christ tells the disciples that those who serve shall be first. When I reflect on this message within the context of mental health, it makes me think about how frequently people benefit from focusing on serving others and serving a larger purpose. We are called as Catholics to live like Christ and serve others, but we often can lose focus of this call and instead focus too much on ourselves. When we serve others, we make a gift of ourselves to them and we recognize that there is more to life and the world than just our thoughts, desires, and feelings. This is the larger purpose that allows us to get outside of ourselves for a time. These acts often result in feelings of purpose, joy, peace, and a closer relationship with Christ. A greater sense of purpose is also an incredible way to avoid or decrease some of the mental health issues that we face such as depression and anxiety. I want to remind everyone that there is a balance between focusing on ourselves and serving others, which we will discuss more in part two of this series. This week, consider praying about new ways to serve others or simply to recognize and reflect on the ways that you already serve others in your work, family life, and friendships.




WITNESS JESUS' RE*A*IL PRESENCE

Parents Matter: Part 2

One of the most disconcerting pictures on display at the Cleveland Museum of Art, the Portrait of Jeremiah Belknap, depicts a 7-year-old boy with the features of an adult face. In 1758, the artist, Joseph Badger, imagined a child as a miniature adult.

That seems to be the operative image of a child that informs the reproductive rights amendment that will appear on ballots this November. The poorly drafted amendment assumes that children, as miniature adults, can make decisions for themselves, and that parents really don't matter. How so?

The proposed amendment uses the broadest possible category, "any individual," to include even a minor child as a party who might seek life-altering sex surgeries and hormonal therapies as a matter of constitutional right. That child (and any other individual) would have "the right to make and carry out one's own reproductive decisions" with or without the assistance of another "person or entity." Certainly, a parent can accompany a child to a doctor, as has always been the case. But this proposed amendment opens the door to have any other "person or entity" perform that function, including teachers and organizations such as Planned Parenthood. That is, the child may proceed without parental knowledge or consent. In fact, the child may proceed without any assistance at all, or even in the face of the opposition of his or her parents.

This constitutional amendment would override current Ohio statutes that offer some protection for parental rights. Parents in Ohio now have the right to exclude their children (from kindergarten through 6th grade) from sexual abuse education and assault prevention. They also have the right to exclude their children (from grades 7 through 12) from instruction on venereal diseases, dating violence and sexual violence. If parents would rather teach their children themselves on these sensitive topics, they are free to do so. They may also seek instruction from other sources they trust, such as churches or medically trained personnel. See Ohio Revised Code 3313.60.

Teachers can plant the seeds in and out of the classroom. Under the proposed amendment, in their earliest grade school years, some impressionable youngsters may step forward with the encouragement of their teachers, and request a change in gender. The teacher would have the right to bypass the parents, and take the child for whatever reproductive healthcare decision the child makes. How is this possible? Because parents, under this amendment, don't matter.

The proposed amendment would bring Ohio into that group of states that permits children to announce to a physician that they need a sex-change operation, sterilization, puberty blockers, and so on—and the doctor's opinion would count for nothing. All this without the knowledge of the parents.

The federal government has recently raced ahead of the states on the issue of birth control pills. The Food and Drug Administration announced that it will make a common birth control pill, known as the Opill, available as an over-the-counter drug by 2024. Anyone with enough money could then buy the pill.

Parents know that girls in their early teens (as young as 12) will not always follow directions exactly as they are set out for them. Although many young girls carefully follow instructions, many who would choose to dabble in sexual relations will display less diligence. They will follow directions in using the pill about as well as they follow directions in cleaning their rooms, brushing their teeth, and doing their homework. Aside from the fact that such children will quickly find themselves "in over their heads" in relating to boys, they may well find themselves pregnant at some point. Such a girl will be sorely tempted to resolve the situation through a "quiet" abortion, which she can obtain using the guidance of a person or entity that is willing to "help" her. One wonders how long a young girl can keep the distress of an abortion quiet.

It is astonishing that some adults cannot anticipate the consternation, anxiety, overwhelming fear and torment they interject into young lives through allowing such decisions. They thoroughly ignore the vulnerability of children and their lack of experience.

Joseph Badger may well have imagined children as miniature adults, but his only offense was a rather outlandish painting. The State's unrealistic image, on the other hand, will cause much pain, agony and heartache that could have been avoided. If only its proponents could understand that parents matter.

Dear Parishioners,

I write today to share an exciting opportunity for our parish and school community. You may be aware of a scholarship tax credit opportunity that is benefiting our school and its students. In a nutshell, Ohio taxpayers may receive a 100% tax credit against their Ohio income tax liability for donations to an approved Scholarship Granting Organization, up to a maximum of \$750 (\$1,500 for married couples filing jointly, when each spouse makes a donation). What a wonderful opportunity to support our students at no net cost to donors!

More good news- students from every Catholic school in the Diocese of Cleveland, including ours, are able to apply for tuition assistance in the form of a scholarship from the Angel Scholarship Fund (ASF), a Scholarship Granting Organization that supports all schools in our Diocese. This fund is being managed locally by the Catholic Community Foundation, and they are accepting contributions that can be designated specifically for scholarships for students at our school (or those of another Catholic school in the diocese). Undesignated contributions are awarded as scholarships across a diocesan-wide pool of applicants from any Catholic school by prioritizing low-income status and need — comparable to the current diocesan tuition assistance program.

Even more good news- all told, more than 4,300 households donated \$4.5 million to ASF in 2022! Included in this total is over \$53,000 that was designated for Ss. Robert and William Catholic School students. I am happy to report that these designated donations are being awarded as Angel Scholarships to 100% of our students in the 2023-2024 school year. I am grateful to all those who supported ASF in 2022, and hope and pray that we will be able to meet and surpass last year's total- Our goal for 2023, to raise \$100,000, might be a stretch, but with more and more generous people like you learning about ASF, I believe we will be successful!

In this bulletin, please find additional information about the Angel Scholarship Fund. I strongly encourage all members of our parish and school community to participate in this program- your support will be a great service to Ss. Robert and William Catholic School students, and will help bolster our efforts to ensure the viability of our school. The process is not complicated- just follow these 3 easy steps:

If desired, review your tax liability from last year (2022 1040 IT, line 8c) to help estimate the amount of your tax liability for this year against which the credit can be taken.

Use the enclosed contribution card to make a one-time or monthly gift to the Angel Scholarship Fund by December 31, 2023.

Claim your tax credit on your 2023 Ohio tax form with the tax credit receipt that will be mailed to you from the Angel Scholarship Fund.
