



PRE-MARITAL QUESTIONNAIRE - FORM B

Required: To authenticate your testimony, choose one of the two options
(1 or 2):

1) At a local Catholic Parish, ask a priest or deacon (or authorized layperson) to verify your identity, administer the oath, and affix the parish seal to your testimony. (This is free of charge.)

- or -

2) A public notary may administer the oath, verify your identity, and include the notary seal to your testimony. (This may include a fee.)

Note to the person administering the oath:

If the witness is unknown to you personally, please ask to view a picture ID and verify the signature of the witness.
