NEW STUDENT APPLICATION & ENROLLMENT FEES (per student)

Application Fee - \$100.00 (Paid with online application and is non-refundable and non-transferable)

New Student Testing Fee - \$50.00 (cash or check due at time of testing)

New Student Enrollment Fee - \$300.00 (Fee is paid when a new student is accepted and completes the online enrollment process. The fee is non-refundable and non-transferable)

RETURNING STUDENTS RE-ENROLLMENT FEE (per student)

(Fee is paid within the online re-enrollment process. The fee is non-refundable and non-transferable) \$200.00 December 29, 2025 – January 31, 2026

\$275.00 February 1 – February 28, 2026

\$300.00 beginning March 1, 2026

SCHOOL FEES (per student)

School Fees invoices are emailed and payment is due through your FACTS account by <u>FRIDAY, JUNE 12, 2026</u>

If enrolling after <u>June 12, 2026</u>, invoicing and payment date will be set up at time of enrollment.

2026 – 2027 TUITION PAYMENT OPTIONS

Thank you for you, choosing Holy Rosary Catholic School (HRCS). Our school takes pride in providing our students with a quality Catholic education while maintaining the lowest tuition in the area. Enrollment fees, school fees and tuition are invoiced and paid through your online account with FACTS Management Company (FACTS). Please review the tuition payment plan options below and choose the plan most convenient for your family. All families will complete an Enrollment Packet in FACTS Family Portal (www.factsmgt.com) yearly. The FACTS payment plan setup will be a required step in the Enrollment process. Tuition will be added by the business office and the agreement will be finalized. Once your information is received and processed by FACTS, you will receive a confirmation notice. This notice will confirm your payment plan information. School fees are not part of the tuition payment plan and are invoiced through FACTS Incidental Billing. Your invoice will be emailed to you. Payment of school fees through your FACTS account is due in full June 12, 2026. If enrolling after June 12, you will be invoiced at time of enrollment and payment will be due through your FACTS account as indicated on your invoice.

FULL TUITION PAYMENT PLAN (FACTS Yearly Enrollment Fee: \$25.00)

FACTS is a quick, secure method for paying your tuition balance in full. Payment methods offered are Credit Card (3.05% fee added) or Automatic Bank Draft with your choice of full payment on the 10th or 20th of August, 2026. There is a <u>2% tuition discount</u> for full payment on these dates. If after this time, the 2% tuition discount will not apply.

SEMESTER TUITION PAYMENT PLAN (FACTS Yearly Enrollment Fee: \$25.00)

Pay your tuition in two installments. Payment methods offered are Credit Card (3.05% fee added) or Automatic Bank Draft with your first semester payment choice of the 10th or 20th of August, 2026, and your second semester payment choice of the 10th or 20th of January, 2027.

Monthly Payment Plan (FACTS Yearly Enrollment Fee: \$55.00)

Spread your tuition balance over monthly installments. Payment methods offered are Credit Card (3.05% fee added) or Automatic Bank Draft on your choice of the 10th or 20th of each month. Total tuition is for ten (10) months of school (August – May); however, to reduce monthly payment amounts, we have set up an eleven (11) month payment plan for those families who are enrolled in HRCS and enrolled in FACTS prior to June 12, 2026. Payments begin in July, 2026. Late fees will be applied to each late payment. Fees will also be applied to each dishonored payment. The final payment is due in May, 2027. Late enrollment in HRCS and/or FACTS will be set up at time of enrollment and will be spread across the remaining months through May, 2027, resulting in slightly higher monthly payments.
