Dear Deacon Steve:

Thanksgiving season greetings from the Chancery! I apologize for the delay in providing this approval letter. Thank you for your submitted 2020-21 budget; we understand that the uncertainty of the impact of Covid-19 will probably present itself during the new fiscal year. Bishop Powers has asked me to respond on his behalf, regarding the proposed budget for Sacred Heart Parish — Almena for the fiscal year beginning July 1, 2020. Bishop understands that your budget projects a total income of \$112,475 and total expenditures of \$87,026; a projected net income of \$25,449 — excellent numbers! Also, no extraordinary expenditures in excess of \$5,000 were indicated in your budget.

According to Article V of the Amended By-laws for parish corporations an annual meeting is to be held prior to June 30 of each year. Given this delayed letter, a meeting in November or December is acceptable. In addition, Article VII paragraph 7.5 states that the directors of the corporation shall approve an annual budget prior to June 30 each year which may include expenditures of \$5,000 or more.

Bishop Powers, by this letter, grants his approval of the proposed budget. This approval is contingent on the approval by the parish corporate board. It will be necessary for Sacred Heart Catholic Parish Corporation to make a corporate resolution approving this proposed budget. Accordingly, the enclosed proxy signed by the Bishop and the Vicar General will enable them to vote "in absentia" at the parish corporate board meeting. This resolution, and the proxy votes, should then be recorded in the minutes of your annual corporate board meeting which was to be held prior to June 30, 2020, but will be held by December 30, 2020. It will be necessary for you to insert the date of the annual corporate board meeting on the enclosed proxy. Please return a copy of the minutes of this meeting and a copy of the dated proxy for our file.
