Minutes of the Joint Pastoral Council Meeting Thursday, February 3, 2022 – 7:00 p.m. St. Anthony Parish Center

- I. Meeting was called to order at 7:00 p.m. by Craig Hohlfeld.
- II. Opening Prayer: Deacon Steve led the council in prayer.
- III. The council reviewed the minutes from the previous Joint Pastoral Council meeting of January 13, 2022. A motion to approve the minutes was made by Greg Montgomery, second by Mary DeFoe. Motion was called and approved unanimously.
- IV. St. Ann Finance Committee Report:
  - St. Ann Finance committee could not hold a meeting due to a lack of quorum.

Deacon Steve reported that as of February 3, 2022, the St. Ann balance sheet reflects a balance of \$12,349.64 in the general checking account and \$54,404.67 in general savings. The perpetual care account has \$30,010.20 in principal and interest. The total of all assets to date is \$99,407.63.

## V. Old Business:

- 1.) St. Anthony church building update:
  - a) Deacon Steve advised the Capital Campaign held its campaign commitment weekend on January 15 & 16. The campaign is doing very well and has already reached its goal in pledges.

## 2.) Sacred Heart-

a.) Anita Tomczik presented a quote from Woodland Signs for two different styles of signs, both measuring 4' x 5', the same dimensions as the old sign. An aluminum lettered sign was estimated at \$300.00. A routed cedar sign with 3 step sealer, painted and angle iron on backside was estimated at \$1,128.00.

It was discussed that we may want a larger sign and it would be nice to have a visual picture or sketch as to what the sign would look like to help in the

decision-making process. Deacon Steve we can afford to spend more money if needed for a larger sign. A target cost can be anything of under \$5,000.00. Anita is going to follow up with Woodland Signs again.

3.) 2022 Lenten Calendar - Deacon Steve provided the council with an official copy of the calendar. Each Thursday night during lent, at 6:00 p.m., there will be Stations of the Cross followed by Adoration. Fr. Tom will hear confessions during the period of Adoration. These events will be rotated among the three parishes, so each parish gets two opportunities for reconciliation during the evening.

Chris Hurtubise will be the guest speaker for a two-night parish mission on March 6<sup>th</sup> and 7<sup>th</sup> at 6:00 p.m. at St. Anthony's. Refreshments to follow each night.

We don't have an additional priest to help with the Easter Triduum this year, so masses will be limited to what Fr. Tom can do on his own. The Triduum will be at Sacred Heart this year.

- 4.) Synod on Synodality Deacon Steve reported that he has only received one submission to date on the questions for the Synod. It is hoped there will be more before the February 15<sup>th</sup> deadline. All are encouraged to participate.
- VI. New Business: There was no new business.
- VII. Committee Reports
  - 1.) Health Ministry Deacon Steve advised that the QPR training is scheduled for February 6<sup>th</sup> at St. Anthony's, and is also scheduled for February 17 at St. Ann's. Both events will be open to the public following Mass.

Health surveys are still out in the parishes.

2.) St. Anthony CCW – The Italian dinner was a huge success bringing in more that \$1,600.00 for the building project. The next dinner will be held on April 3, 2022.

"Raise the Roof" variety show will be held April 29<sup>th</sup> at the Cumberland American Legion. 200 tickets will be sold. Price has not yet been determined.
