Serving as a sponsor calls for the ability and desire to share openly what it means to live as a Catholic, leading a life "in harmony with the faith and role to be undertaken."

### REQUIREMENTS FOR SPONSOR

These requirements flow from the above understanding of the Sacrament of Confirmation and the role of a sponsor set forth in the Code of Canon Law #874.

- At least 16 years of age, and is a fully initiated member of the Roman Catholic Church (has been Baptized, received First Communion and Confirmation, and is in good standing with the Catholic Church).
- An active member of the Roman Catholic Church, who attends Sunday Mass regularly, prays and participates in the Sacramental Life of the Church (receives regularly Holy Communion, celebrates the Sacrament of Confession, and has an active prayer life).
- If married, a sponsor must be validly married in the Roman Catholic Church.
- Someone other than candidate's mother or father.

#### PASTOR RECOMMENDATION TO BE COMPLETED BY SPONSOR'S PASTOR

Your sponsor's pastor must ascertain the spiritual qualifications of the sponsor. To be admitted to the role of sponsor, a person must have completed the sixteenth year, be fully initiated and leading a life in harmony with the faith and role to be undertaken, not bound by any canonical penalty, and not be the father or mother of the one to be confirmed (canon 873, canon 874, canon 892, canon 893).
