## **AFTER CARE AND AFTER SCHOOL ACTIVITIES**

- REGISTERED CHILDREN, WHO ARE SENT TO AFTER CARE, THEN GO TO AN ACTIVITY AND ARE SENT BACK TO AFTER CARE FOR PICK UP, ARE CHARGED THE RATE THAT COINCIDES WITH THE TIME THEY ARE PICKED UP FROM AFTER CARE.
- REGISTERED CHILDREN, WHO ARE SENT TO AFTER CARE, ARE DISMISSED FROM AFTER CARE TO
  GO TO AN AFTER SCHOOL ACTIVITY (TAKING THEIR BELONGINGS WITH THEM) AND ARE PICKED
  UP DIRECTLY FROM THAT ACTIVITY, ARE CHARGED THE RATE WHICH COINCIDES WITH THE TIME
  THEY LEFT AFTER CARE. IF THE CHILD IS NOT PICKED UP ON TIME AND MUST BE SENT BACK TO
  AFTER CARE, THEY WILL BE CHARGED THE RATE WHICH COINCIDES WITH THE TIME THEY ARE
  PICKED UP.
- IF A STUDENT IS PLACE IN EDP BY THE SCHOOL OFFICE BECAUSE HE/SHE WAS NOT PICKED UP AT DISMISSAL, THE FAMILY WILL BE BILLED FOR THE APPLICABLE FEES, INCLUDING REGISTRATION.
