Dear Parents,

St. Clare of Assisi – St. Francix Xavier School is happy to provide an After-School Program for all our students, beginning Monday, September 11th and ending on June 11, 2024. The program operates from Monday-Friday, from dismissal to 5:45 pm and half days from 11:30 am - 5:45 pm. Currently, there are 175 school days of which 165 days have aftercare available.

The school offers several plan options, to accommodate the different needs of our parents (Rates are based on 165 after school days).

AFTER SCHOOL PLANS

If you choose the Daily Plan 1 - \$30 as needed, payment must be made to the school directly. You must also include \$30 registration fee when registering your child. All daily payments must be sent in the brown envelope the school will provide to you along with a note to your child's teacher advising them that your child should be sent to After-School that day.

If a situation comes up, where you are delayed in picking up your child that day and they must attend After-School, payment is expected the following day directly to the office.

If you use the daily plan more than twice a week, you must sign up for a plan.

We strongly recommend choosing a monthly plan to maximize your savings.

BILLING

UPK students are billed in eight (8) months from October 2023 through May 2024 using Brown Envelope. Students K-8 are billed in eight (8) months from October 2023 through May 2024 and added to their Blackbaud tuition.

LATE PAYMENT POLICY

Any payment that is <u>NOT</u> posted on your due date is considered late and will **be subject to a late fee of \$15.00**. Late Fees are assessed 5 days after a family misses its due date on the 1st.

AFTER SCHOOL PROGRAM CHANGES

If for any reason you need to change your program option, you must fill out a Change/Withdrawal Form indicating the effective date of the change. These changes must be handed into the office one month prior to the effective change date. (Example: if you want your change to start on November 1st, the form must be submitted into the office by October 1st). Form attached.

Once the office receives this request, we will send home confirmation stating that we received your new updated form. If you do not receive confirmation of your change, please contact the office. No verbal request of changes will be accepted!

There will be no after school program on days that school is closed. In addition, we will have no after school program on the following days:

The day before Thanksgiving break
The day before Christmas break
The day before Easter break
The last three days of school in June before summer break

Please keep in mind in extreme emergencies (such as bad weather), we may have to cancel the After-School or end the program early for the safety of the children and staff.

At times this notice maybe done on short notice through an IRIS Alert. As a working parent, you may not be able to pick your child up on such short notice. It is YOUR responsibility to reach someone that will be able to pick up your child at the specified time. Arrangements could be made with a classmate's mom should this happen or family member.

REGISTRATION

If you are interested in enrolling your child, you <u>MUST</u> fill out the attached form and return it to school by September 8th along with the Contract and the emergency paper filled out. There is a \$30 registration fee (per student) due at Registration. PreK will receive a brown payment envelope to be used on the first of the month to pay for After-School beginning in October and ending in May. St. Clare's - St. Francis after-school will be billed to their Blackbaud Tuition Account beginning in October and ending in May.

Please note - Should a child display behavior which jeopardize the safety of themselves and others, the staff will contact the child's parent or guardian, and request that the child be removed from the program for that day. Repeated suspensions could result in termination of care.
