# **OBTAINING BACKGROUND CHECKS**

#### 1. PA Sate Police Criminal Record Check

Can be obtained online at https://epatch.state.pa.us - Cost is free for all volunteers. Clearance is good for 5 years.

#### 2. PA Department Human Services Child Abuse History Clearance

Can be obtained online at www.compass.state.pa.us/CWIS - Cost is free for all volunteers. Clearance is good for 5 years.

#### 3a. Federal Criminal Background Check - If you have lived in PA continuously for 10 years or more:

Go to www.churchofsaintmary.org website and scroll to the bottom and select the "Safe Environment Volunteer Information" and then click on "Disclosure Statement Application for Volunteers." Clearance is good for 5 years.

#### 3b. Federal Criminal Background Check - If you have NOT lived in PA continuously for 10 years or more:

Information is available online at: https://uenroll.identogo.com and use service code of 1KG6ZJ. This code is only good for volunteers. If you are a Parish or Saint Mary School employee please contact the Parish Office Center for the correct code. Federal Criminal Background Check is good for 5 years.

### 4. To register for the Safe Environment Part I "Protecting God's Children" Virtus

Go to www.virtusonline.org and select "First Time Registrant" for a list of dates and locations and to register. Upon completion of class, certificates will be mailed to the parish listed as the individual's location of service. You can also reprint your certificate from this same website.

## 5. To register for Safe Environment Part II: Mandated Reporting of Suspected Child Abuse:

Go to www.childyouthprotection.org and click on the "Training Institute" tab.

### 6. To complete the Safe Environment Part III: Mandated Reporter Acknowledgment Form:

Go to www.churchofsaintmary.org website and scroll to the bottom and select the "Safe Environment Volunteer Information." Volunteers will need to sign the "Mandated Reporter Acknowledgement Form"
