

Tuition and Fees 2024-2025

Tuition for each quarter is non-refundable after the first class day of that quarter.

Tuition rates will be prorated for students starting after a quarter has already begun.

Families who wish to shorten the class day for their Pre-K students are always welcome to do so.

Enrollment Fees/Tuition Deposits

For New Families:

o Application fee: \$150 (per family, non-refundable)

o Tuition deposit: \$500 (per family)

For Returning Families (including additional students):

o Registration fee: \$100 (per family, non-refundable)

o Tuition deposit: \$500 (per family)

School Fees (Non-refundable after the first day of school)

\$150 per student (all grades)

In addition to tuition, an annual School Fee (per student) is assessed to pay for classroom activities. In the event of special projects or unexpected expenses, students may be asked to provide additional supplies or pay supplementary fees.

PAYMENTS through TADS

All families are required to have an active TADs billing account. Families must select one of the two options listed below:

- 1. Payment in Full: Payment is due July 5, 2024. A \$100 discount will be applied if paid by July 5. Billing account set-up for sports, lunches, etc. will incur a onetime \$40 fee for the year.
- 2. Installments: Tuition that has not been pre-paid in full must be paid by monthly automatic withdrawal via TADS. Payments must begin in July 2024 and tuition must be paid in full by the following June 25th. This option requires a one-time \$55 handling fee paid to TADS.

Financial Aid for active parishioners of Holy Family Church

For Tuition Assistance and Multi-Student Discounts, you must meet the following criteria or apply for an exception from the pastor:

- o Registered member of Holy Family Church for at least one year prior to the beginning of the school year
- o Regular Sunday Mass attendance at Holy Family Church
- o Appropriate and verifiable stewardship to Holy Family Church
- o Participation in Holy Family's activities & fundraising efforts

Financial aid takes two forms:

- 1. Tuition Assistance: Parishioners may apply for tuition assistance through TADS. A committee will review applications based on need. Failure to meet the deadline disqualifies you from consideration. For calculating tuition payments, the financial aid amount is distributed evenly across the whole year.
- 2. Multi-Student Discount: In the case of parishioners enrolling multiple students, the family will receive an automatic discount deducted from their total tuition bill:
 - o \$300 discount for 2 students
 - o \$800 discount for 3 students
 - o \$1,950 discount for 4 students
 - o \$6,150 discount for 5 students

We do not participate in the government subsidized lunch program but are happy to assist families in need. Please contact the school office for further information as we wish to ensure your child's nutritional needs are met. The parish's "Care Fund" provides assistance in these situations.

Fundraising

Fundraising income allows Holy Family Academy to charge less for tuition than the actual cost per student as well as provide financial aid for those who otherwise couldn't afford to attend. Our operational budget depends on all families participating in the school's fundraising activities. This is the only way that we can mitigate the rising cost of education.

All families are expected to raise a minimum of \$650 through one of our fundraising events or activities. Some families may wish to make an appropriate financial contribution instead. Failure to actively participate will be taken into consideration when reviewing financial aid applications.

Transportation Reimbursements from School Districts

If your local school district reimburses you for transportation, our accounting office will process the reimbursement and issue a check to you. If you are not current on tuition payments, this amount may be applied to your outstanding balance.

March 27, 2024	Signed Tuition Agreements are due

^{*}Non-Parishioners entering Pre-K or Kindergarten may not be invited to enroll on December 15 due to space limitations. Enrollment will be confirmed individually as space becomes available.
