
## Andrew Crockett Memorial Scholarship Fund

Along with being an honor student and

class leader, he was a team leader in all sports he participated in, especially basketball. He was a role model to his friends, fellow students, and team members, and will be forever in the hearts of all who knew him.

Each year, this tournament is held in Andrew's memory, and all proceeds go directly to the Andrew Crockett Memorial Scholarship Fund at Bishop Ryan.

### **Tournament Information**

Completed registrations must be accompanied by the required entry fee. Each parent must sign the registration form.

Teams will be registered on a first-come, first-served basis. The tournament will be limited to eight teams per division, and divisions may be combined at tournament director's discretion.

This tournament is open to school-sponsored and traveling/pickup teams.

Each team is guaranteed three games.

Awards will be given for 1st, 2nd, and 3rd places.

Games will be two 18-minute halves. The clock will stop for timeouts only. In the last two minutes of the game, the clock stops on all whistles if the game is within 20 points.

### **RULES:**

- \*Man-to-man defense is the only defense allowed in the 3rd-6th grade divisions.
- \*Any defense will be allowed in the 7th and 8th grade divisions.
- \*Full-court press is not allowed in any division when a team is up by 20 points or more.

Additional rules and regulations will be provided prior to game time.
