Un-leased exhibition spaces existing as of January 16, 2023, will be offered to applicants at the rate \$110. If space remains un-leased the week prior to the Craft Bazaar, the PTC has the right to rent to other vendors as they deem necessary to fill empty spaces and drive customer traffic and sales. If Vendor cancels their contract a full refund will be given for requests made prior to October 1. A 50% refund will be given for requests made between October 1 and October 15. No refunds will be granted for cancellations occurring after the 15th day of October immediately preceding the scheduled Bazaar dates.
