The truth that life is a precious gift from God has profound implications for the question of stewardship over human life. We are not the owners of our lives and hence, do not have absolute power over life. We have a duty to preserve our life and to use it for the glory of God, but the duty to preserve life is not absolute, for we may reject life-prolonging procedures that are insufficiently beneficial or excessively burdensome. Suicide and euthanasia are never morally acceptable options.

#### NATIONAL CATHOLIC BIOETHICS CENTER

There is an obligation to provide food and water, even if medically assisted, unless they cannot reasonably be expected to prolong life or when they would be excessively burdensome for the patient or would cause significant physical discomfort.

## CATECHISM of the CATHOLIC CHURCH (2276 –2283)

Those whose lives are diminished or weakened deserve special respect and should be helped to lead lives as normal as possible.

**EUTHANASIA** consists in putting an end to the lives of handicapped, sick, or dying persons. It is morally unacceptable, and must always be forbidden and excluded. Discontinuing medical procedures that are burdensome, dangerous, extraordinary, or disproportionate to the expected outcome can be legitimate. Palliative care should be encouraged.

SUICIDE is gravely contrary to the just love of self and for the living God. We should not despair of the eternal salvation of persons who have taken their own lives. By ways known to Him alone, God can provide the opportunity for salutary repentance. We pray for persons who have taken their own lives.

Anyone who desires <u>euthanasia</u> or <u>suicide</u> should receive loving care, psychological and spiritual support, and appropriate remedies for pain and other symptoms so that they can live with dignity until the time of natural death.
