Synod Snippets by Fr. Jason

This week we conclude our summary of Chapter VII of the Synod Directory and, thus, the Directory as a whole.

Section III deals with "salaries and compensations." It explains that the bishop approves and sets annual salaries and other compensation rates for clergy (260). Parishes must provide a salary, a furnished rectory, and household expenses for priests assigned to them (261). This does not include purchasing personal items for priests (262). Parishes with missions are to share salaries, benefits, and household maintenance costs, but items specific to one parish will be paid by that parish (263). Parishes which share a pastor annually review (in parish and finance council meetings) their cost sharing agreements. Statute 264 explains that it is the pastor's right to hire and determine salaries and benefits paid to parish employees, after consultation with the parish finance council, etc. (264).

The chapter then moves on to discuss "Mass Stipends," which were discussed in detail in a previous column. To what was previously written, I will add just a few details. It's good to know that priests and parishes cannot accept more Mass intentions and stipends than can be offered in one year (272). It's also good to know that the pastor of every parish is obliged to offer, every Sunday, a Mass for all the people living in his parish boundaries (273). This means that a priest is praying for you at the altar every week, no matter where you live!

The next sections focus on special collections, acceptance of gifts, fundraising, and parish facility usage rules. In short, they explain that parishes are to take up approved national collections (280). They explain that parishes must seek the permission of the bishop prior to collections other than the usual Sunday, Holy Day, God's Share, or other approved national collections (284). This means the pastor cannot, for example, spontaneously take up a collection for his favorite personal charity.

The very last statutes of the Synod Directory explain the parish facility usage policy. It says that "only diocesan and parish sponsored events can be held at diocesan or parish facilities. Exceptions to this norm may only be granted by the pastor or administrator and in accord with these Statutes, thus ensuring that the necessary insurance has been acquired and that the event is not contrary to the principles of the Faith" (289). Providing the appropriate insurance may be a hassle for organizations like the Knights of Columbus or the Ladies VFW Auxiliary, but such insurance does protect those organizations, the parish, and anyone who may be involved in an accident at related events.

With that, I conclude this series of bulletin columns on the Diocesan Synod. I hope these words have been helpful. As always, if you want to know more, you may read the Synod Directory for yourself at http://bismarckdiocse.com/synod.
