#### Thoughts concerning the cemeteries!

A review of the "rules" for the cemeteries will need to be made since there are now four cemeteries Fr. Gallagher and the office staff have to manage. Before that takes place and those new rules are published there are some important ones which need to be observed at all times: They are:

-Absolutely **no artificial flowers or decorations**. They are made with wire and materials which if run over by a lawn mower or affected by a weed trimmer can be VERY DANGEROUS. Any artificial flowers should be removed immediately.

-There is to be no planting of bushes or shrubs around head stones or on graves. These obstacles to the maintenance of the cemetery are very time consuming for employees and expensive in the regular care of the cemetery.

-Families are certainly able to place a stone on a grave which they have the easement to. It is expected and polite to let the office of the parish know that this is taking place so that our records of your graves show headstones on them. Identifying graves becomes very difficult without this information.

-When a death in the family has occurred it is proper for the parish to activate the digging of a grave **not** a member of the family. Those who dig graves are employees of the parish and are asked to do their work from the office of the parish. This assures that someone isn't buried in our cemetery that we do not know about.

-A person who buries cremains themselves and does not contact the parish to have it done through a parish employee is committing a crime and will be prosecuted. We have every legal right to know who is buried in our cemetery.

We will be in touch with more concerning this important topic.
