**New Rules and Guidelines Proposed for all parish
cemeteries:**

- A place of burial is not purchased by the family but is an easement granted under the authority of the Catholic Church and the State of New York by the family for the purpose of the burial of a family member. This piece of land is not owned but is granted use with permission from the owner of the land, the Diocese of Ogdensburg for the purpose of burial and maintenance by the local parish.
- In each "grave" the current pastor allows for the burial of one full body

- or the burial of up to three cremated remains.
- Family of the deceased may tend to this grave in the following ways:
 - They may plant live flowers in front of the main stone within the width of the stone and one foot from the face of the stone wide.
 - They are responsible for the care of such plantings for the duration of the growing season.
 - They may not use artificial flowers or decorations of any kind as these are a liability to those who care for the cemetery.
 - They may not plant trees or shrubbery of any kind.
 - They are advised that flowers left at a grave in pots or containers will not live long and will not be moved for the mowing of the grave and it will be the fault of those leaving them when the grave is not mowed or closely trimmed.
 - Solar implements are allowed but must be adhered to the monument for whom they are intended.
 - American flags are appropriate for the grave of a veteran on Memorial Day but will be removed following a two week period due to liability of caregivers and disrespect for a national flag as it becomes wind torn or faded. Each cemetery has an American Flag flying on a pole in respect for all veterans.
 - Our cemeteries are officially closed during the winter months due to liability issues. Anyone entering a cemetery during this season will be considered a trespasser.
 - These rules exist so that the care and the visitation of our cemeteries can be best maintained and best enjoyed by all. We are grateful for your care and diligence in following the above rules.
