Tuition has been determined for the 2023-2024 school year by the Finance Committee. As you read this chart, keep in mind that a registered parishioner will be billed the “higher-rate” tuition if the minimum Sunday envelope contribution has not been met. Also, please note that the cost to educate *each* child in our school is over \$5,900.00.

The minimum donation from registered parishioners in Sunday envelopes for the current school year is \$950. This amount must be recorded between 4/1/2022 to 3/31/2023 in order to receive the regular rate for the 2023-2024 school year.

The tuition rates are as follows:

Grades 1 through 8

Regular Rate Tuition per Family:

1 student	\$4,000
2 students	\$7,585
3 students or more	\$9,530

**Tuition for Registered Parishioners who have not donated \$950 in Church envelopes by 3/31/2023,
Out of Parish Families and Non-Catholics registered before 2016-17 school year:**

1 student	\$5,250
2 students	\$9,945
3 students or more	\$12,470

Non-Catholic Families registered after the 2016-2017 school year:

1 student	\$5,450
2 students	\$10,325
3 students or more	\$12,940

Kindergarten Tuition (Full Day Program)

Parishioner	\$4,000

Pre-Kindergarten (Full Day 4 yr old Program)

With sibling enrolled at SATG	\$4,950

The following fees will be billed through the FACTS system for payment due by **September 8, 2023:**

\$65 per student - stationery fees for items bought through school, Terra Nova testing and Religion books

\$10 per family - membership to the Home & School Association

\$50 per family - daily lunch monitors who stay with the students

\$135 per family - technology, maintenance, replacement and applications

Total fees for 1 child = \$260; 2 children = \$325; 3 children = \$390; 4 children = \$455

\$45 per child – Kindergarten fee

FINANCE COUNCIL REMINDERS
