

CRC Golf Cart Rental Agreement

Following Items Must Be Completed by CRC Staff Prior to Rental:

1. Copy (front & back) of Valid Driver License of Authorized Driver Who is 21 years old or older
2. Payment in Full
3. Signed Contract
4. Review of Contract w/ Driver

Groups are invited to rent a CRC Golf Cart for retreats at a rate of \$350 per cart, per retreat (max 4 days). By renting the golf cart, the group agrees to adhere to the following terms and conditions:

1. Driver Requirements

- The driver of the golf cart must be **21 years old or older**. Proof of age may be required before rental.
- The driver should have a valid driver license.

2. Speed and Usage on Walkways

- **Speed Limit:** While driving on CRC property, a speed limit of **3 MPH** (normal walking speed) must be observed.
- Driving on walkways is allowed only for guests with physical limitations or for moving equipment; **joy-riding is prohibited**.

3. Driving on Sidewalks

- When crossing sidewalks from one grassy area to another, **do not drive at high speed**. Sudden or fast impacts with sidewalks may damage the golf cart's tires.
- **Weight Limit:** Golf carts cannot carry more than **800 pounds** to avoid damaging the grass and the cart itself.

4. Parking Restrictions

- **Parking on Walkways:** Golf carts **may not be parked on walkways** as it could obstruct the sidewalk and make it difficult for wheelchair users or other guests to pass. Please be considerate of others.
- **Designated Parking Only:** Golf carts should be parked in designated parking spaces only.
- At the end of the day, group is responsible for parking the Golf Cart under the designated parking area and plugging it in, **to charge it overnight**. This is important to do every night, to ensure Golf Cart is charged and ready for your group use during the day.
- Wheelchair Ramp Golf Cart does not require charge, it is gas-powered. It cannot drive on covered walkway due to ramp extension. It can be used to shuttle to and from Grotto (be mindful of benches to avoid hitting them) & Bayou.

5. Prohibited Areas

- **Main Courtyard Grass:** Golf carts **are not allowed on the grass in the main courtyard** at any time. Driving on the grass damages the area and detracts from the retreat environment.
- **Wet Grounds:** Driving on any grass areas is prohibited when the ground is wet to prevent damage to the lawn.

6. Damage Responsibility

- The group renting the golf cart **assumes full responsibility** for any damage to the cart, personnel, or CRC property. The Christian Renewal Center will seek appropriate remedies from the responsible party for any such damages.
- Most common damage is a group driving into a post on the sidewalk. To replace a post, the cost is \$150 (this includes labor and staff time). This is in addition to any damage done to the Golf Cart.
- To prevent damage of the seats, only people are to ride on cushion seats. Do not put coolers or items on the cushion seats.

7. Safety and Conduct

- These rules are designed to ensure the safety and protection of all guests. **Any unsafe, discourteous, or dangerous driving practices** will result in the group being prohibited from using the golf cart(s) for the remainder of the retreat and no refund will be given.
