Revenue: Each parish is responsible for and retains its own revenue (funds are not commingled). Operating revenue consists primarily of offertory and special collections, facilities rental income and fundraising/bingo proceeds. Extraordinary revenue consist of interest income and capital donations.

Expenses: Since becoming a Family of Parishes, several of our common expenses are now shared. This includes the expenses for our central office and rectory at Holy Name of Jesus. Also shared are the wages of our Priests, Lay staff and Administrative staff that serve all four parishes. Most shared expenses are apportioned to each parish at an agreed formula. Each parish is still responsible for the expenses of their buildings and property such as insurance, taxes, utilities, repairs and maintenance, and capital improvements. Staff assigned to one parish only are not shared. Extraordinary expenses are typically large expenditures of a capital nature or major improvements.
