

So, if your faith in God has ever been plagued by doubt, riddled with insecurity, I





Greetings and peace be with you my dear sisters in Christ.

I have been thinking a lot about being blind, eyes that are unseeing, and what that means to me on a spiritual level. How often do we not see something that is right in front of us? How often do we rationalize what we see so our actions can be justified? Only Jesus can heal our blindness and give us eyes to see the truth. A sight given with grace and mercy. A sight with love, compassion, truth, honesty, and humility.



I attended a multi-district workshop in Round Rock not to long ago. Father talked about how we are beloved daughters of God. We are beloved, not because of what we do or have done, not because of how much money we have or how pious we are, and not even because of who we know or how many boards we volunteer for. We are beloved because God made us in his image to serve him. 



JANUARY 26, 2023

The regular meeting of Court Our Lady Queen of the Lake No. 2364 was called to order by Regent Katie Bailey on January 26, 2023, at 6:33 p.m. in person.

Attendance: 27 members + 5 Officers + 3 guests

Circle of Love: Juanita Oppermann reported we will be submitting four Circle of Love Reports to State. Reports completed and ready to mail are Respect for Life and Leadership. We will be working on Quality of Life and Family. We will have all four reports submitted by the deadline of March 1, 2023.

Prayer Blankets: Binnie Bauml reported that in 2022, The Prayer Blanket Committee gave away 161 Prayer quilts. They also gave two quilts to OLQP which raised \$700.00, four quilts to Pregnancy Help Center, two quilts to Uvalde School, a quilt for our parish raffle, and a lap quilt for CDA Spaghetti Dinner Raffle, and a quilt for Becky Brown, State Regent. The committee also made and distributed to the residents at Country Village 45 small lap quilts/prayer blankets. The committee also helped WOSM make the quilt for Mums and Mistletoe raffle. Education: The entries for the local level of the National Education Contest have been received. In Division 3: one entry for Art. In Division 2: two entries for Computer Art, eight entries for Poetry, two entries for Essay, and 14 entries for Art. Instead of \$25.00 for first prize the court will be awarding \$20.00 to match the first prize given by the Angleton court.

<u>Ways & Means:</u> Chicken Spaghetti Dinner - Sandy Seeley reported plans are well under way for the fundraiser to be held, April 23, 2023. The date is booked for the predinner selling of the raffle tickets. The court will be selling raffle tickets after all Saturday and Sunday masses starting on March 1st. 

FEBRUARY 23, 2023

State Convention: Katie Bailey reported that the state convention will be held at the Moody Gardens, Galveston, Texas April 26 - 30, 2023. All reports have been completed and submitted to the state. These reports include the following: Circle of Love – Family, Leadership, Quality of Life, Respect for Life, and Spirituality. National Newsletter contest materials have also be sent to state. The list of our deceased members has been made and sent to the state, for the memorial mass to be held at the convention. Ten members have signed up for the whole convention. 



Power of Prayer

A Special Thanks to All Who Praved for our Family

"Our God made each one of us perfect and gave us gifts to able to live a full life. Our lives changed a year ago when our family got covid. Everyone recovered after a week, but my daughter Alexis, who was born with a metabolic disorder. She started to change emotionally, she started to become agitated, and day after day a new symptom showed. Some days she couldn't talk, other days she couldn't see, and yet other days she didn't even recognize us. This is when I turned to my CDA sisters and asked for prayers, January 2022. After requesting prayers from our CDA sisters, by suggestion of her geneticist, we took her to a neurologist and all the studies began. All her doctors pointed out that people that take medication for many years like her, sometimes the brain would be affected.

Several months passed and nothing was definitive. At this point Alexis was completely gone mentally. But we did not give up. Weekly we sent out requests for prayers through our CDA Prayer Requests. At this point, everything needed to be done for her: bathing, dressing, taking her to the restroom. In December Alexis stopped eating, sleeping, and taking medications. Alexis was hallucinating. We called her neurologist and he suggested we take her to Baylor St. Luke emergency room; on December 10, 2022, she was admitted. During the 31 days in the hospital, she endured some painful testing, and for Alexis not to be alone Daniel and I took turns staying in the hospital with her. Thanks to all the prayers, Daniel and I were able to endure the pain of seeing our daughter suffer and the physical tiredness.

Through all this we asked for prayers that the doctors would figure out what was wrong with my daughter. Many people, including CDA sisters, deacons, and a few priests were praying and saying Mass for her. There were some days that I was so tired that I couldn't pray but say "Father I place my daughter Alexis in your arms". Daniel and I were able, because of everyone's prayers, to bear the agony of seeing our daughter Alexis going through the pain of losing her mind.

The hardest part was when the doctors decided to transfer Alexis to a psychiatric hospital. Since she is an adult, we had no say as to which hospital she was going to be taken. To our dismay, Alexis was taken to the hospital with the worst reviews in the area. From the moment she was admitted we saw the disorganization and the lack of compassion in the people working there. The pain that I felt leaving my incapacitated daughter in a place where I didn't know if they were going to take good care of her was the hardest thing that I ever endured.

We could only visit her three times a week for one hour and one person at a time. I won't describe to you the conditions and the behavior of the people that work there, because by this point that didn't matter anymore because I had given everything to God: my pain, my worries, and above all my daughter. Alexis stayed 10 days at this place and only because of the prayers, she is back. Alexis continued to be on the Prayer Request List.

Monday January 16, 2023 was my turn to visit Alexis at the 6:40 p.m. visiting time. While I was there, she was lost in her world and I was greatly disheartened to not see any improvement in her condition. I went home and prayed for her. Next day early in the morning my phone rang and to my surprise it was Alexis. She asked me why she was in the hospital. She said she was fine and didn't needed to be there. She said they had ran out of her metabolic medication and to please bring her some more medication. Alexis was fine from one day to the next, it was God's answer to all the prayers.

Alexis stayed 3 more days at this place after her phone call. She is back home and doing better. Alexis is now enrolled in college, can't drive until doctors are sure medications are not going to cause adverse effects. We have no definitive diagnosis; they only said that Alexis suffered a Psychotic episode. Alexis doesn't remember the last year of her life. She has an uphill battle possibly for the rest of her life, but everything is possible with God."

2 Corinthians 12:8-9 *Three times I prayed to the Lord about this and asked Him to take it away. *But His answer was: *My grace is all you need, for my power is greatest when you are weak." I am most Happy, then to be proud of my weaknesses, in order to feel the protection of Christ's power over me."

Gemma's Best-Ever Irish Scones Recipe Author: Gemma Stafford Prep Time 20 mins Cook Time 22 mins Total Time 42 mins

With a lightly sweet crust and densely moist center, my Best-Ever Irish Scone recipe is a tried and true classic. Take it from an Irishwoman and chef!

Course: Breakfast, Dessert Cuisine: Irish Servings: 12 scones Calories: 376 kcal

Ingredients

- 4 ¾ cups(1lb 8oz/680 g) self-raising
- flour (plus extra for dusting)
- 34 cup (6oz/170g) butter (frozen)
- ½ cup (4 oz/115 g) granulated sugar
- 3 level teaspoons baking powder
- 1 cup (5 oz/142 g) raisins/sultanas
- 2 large eggs (beaten)
- 1 ¼ cup (10 fl oz/300 ml) whole milk

Instructions

In a large mixing bowl, add the selfraising flour. Using a cheese grater, grate the frozen butter in until it is all gone. (Alternatively using a pastry cutter, cut/rub the butter into the flour until fully crumbed and resembles coarse bread crumbs. Stir in sugar, baking powder, and



- In a small mixing bowl, whisk eggs and milk until thoroughly combined. Pour the mixture into your flour mix and stir until a soft dough is formed. Transfer dough to a floured surface and press to 1- inch thick. (If your scones are not forming a dough add a little more liquid.)
- Cut scones out with a round 3-inch cookie cutter.
 Gather remaining dough in a ball, re-flatten then cut more scones. Repeat until the entire batch of dough is cut into scones. It will yield 9-12
- Place cut scones onto a baking tray lined with parchment and brush with egg wash.
- Bake at 425°F (210°C) for roughly 22-26 minutes. (Update: In the video, I said 12 minutes but to get them really golden brown you will want to bake for longer)
- Cool on a wire rack for a few minutes before serving with butter, jam, or fresh cream. Store leftover scones in an airtight container at room temperature for up to 2 days. Heat in the oven to refresh.

Recipe Notes

BAKE TIME: In the video, I said 12 minutes, but to get them really golden brown you will want to bake for longer. I ended up baking for over 20 minutes — but due to differences in ovens and elevations, your timing may vary! Just keep an eye for the perfect color.

Best Big, Fat, Chewy Chocolate Chip Cookie

These cookies are the pinnacle of perfection! If you want a big, fat, chewy cookie like the kind you see at bakeries and specialty shops, then these are the cookies for you!

Prep: 10 mins Cook: 15 mins Additional: 15 mins Total: 40 mins Servings: 18 Yield: 1 1/2 dozen Ingredients

- 2 cups all-purpose flour
- ½ teaspoon baking soda
- ½ teaspoon salt
- ¾ cup unsalted butter, melted
- 1 cup packed brown sugar
- ½ cup white sugar
- 1 tablespoon vanilla extract
- 1 egg
- 1 egg yolk
- 2 cups semisweet chocolate chips



Directions

Step 1

Preheat the oven to 325 degrees F (165 degrees C). Grease cookie sheets or line with parchment paper.

Step 2

Sift together the flour, baking soda and salt; set aside.

Step 3

In a medium bowl, cream together the melted butter, brown sugar and white sugar until well blended. Beat in the vanilla, egg, and egg yolk until light and creamy. Mix in the sifted ingredients until just blended. Stir in the chocolate chips by hand using a wooden spoon. Drop cookie dough 1/4 cup at a time onto the prepared cookie sheets. Cookies should be about 3 inches apart.

Step 4

Bake for 15 to 17 minutes in the preheated oven, or until the edges are lightly toasted. Cool on baking sheets for a few minutes before transferring to wire racks to cool completely.


