Code of Professional Conduct Policy for Minors Working with Younger Children

Thank you for your commitment to working or volunteering in the Catholic Church! It is indeed a great privilege to be a disciple of Jesus Christ and help spread the Gospel message. But with this role comes new and important responsibility. Your parish, school or agency has expectations of trust that you must now live up to in a deeper way. As a minor yourself, it is important that you follow certain rules, both for your protection and the protection of those children you will be serving. The Church takes the issue of misconduct very seriously and any misconduct by you will be carefully evaluated. Also, you are urged to report any instances of misconduct you might witness to your adult supervisor.

PROFESSIONAL CONDUCT FOR EMPLOYEES OR VOLUNTEERS WHO ARE MINORS:

- Always be aware of your own actions as well as the actions of those with whom you serve.
- Never be alone with younger children in your care. All of your work must take place in a public location where it can be seen by others.
- Never have physical contact with children in your care, except when appropriate in the course of your duties (e.g. consoling an injured child, holding the hand of a child when using stairs, etc.).
- Never use physical force or demeaning or inappropriate language when working with younger children in your care.
- Do not discipline any younger children in your care. Discipline is the responsibility of your adult supervisor.
- Do not accompany a young child in your care to the restroom unless an adult over the age of 21 is present, unless the health condition of the child makes it absolutely necessary.
- Do not access locker rooms, shower rooms or dressing rooms used by younger children in your care unless an adult over the age of 21 is present.
- An adult over the age of 21 must be present at all times when you are on an outing with younger children in your care.
- Do not drive children in your care.
- Be aware that Archdiocesan policies on child abuse are to be followed without exception.

Immediately alert your adult supervisor if you are unable to meet the above obligations or have questions about what is required of you.
