- Provide direct, differentiated instruction for multi-age classes of up to 12 students, small groups, and individuals inside and outside of the classroom
- Prepare and execute differentiated lessons in multiple subjects including, but not limited to, English Language Arts, Social Studies, Math, and Science
- Meet the needs of students with varying backgrounds, learning styles, and learning needs
- Integrate Wilson Reading Systems instruction: whole class, in small groups, and individually into the Grade Level English Language Arts curriculum
- Integrate Making Math Real instruction: whole class, in small groups, and individually into the Grade-level Math Curriculum
- Provide Science Technology Engineering Mathematics (STEM) using the Next Generation Science Standards when teaching science curriculum
- Model Catholic values for students across the curriculum and uphold the Christian code of conduct
- Provide a learning environment in which the students will engage in positive learning experiences
- Use classroom management systems that focus on the social and emotional needs of the students
- Assess students' work done in class
- Provide bi-weekly family updates regarding student progress
- Prepare progress reports and trimester reports for parents
