# a. Strategic Goal A: Extending God's Kingdom

- i. Net Promoter score "How likely would you be to recommend to others Nouvel?"
- ii. Feeder Elementary Schools, partnering within the Diocese discussed as an additional bullet point. Exploration and included in strategy.
- iii. 5 to 10-year plan for growth. Recruitment (Marketing and Head of School) and Retention (Teachers/Principals). Reviewing those who leave and why to shore up retention. Expand the Ambassador Program to include parents and students. Survey data to be shared with the Board. Numbers should be shared, not percentages.
- iv. How are we measuring success. Decuf indicated we must add measurable goals to the Strategic Plan. Overall Growth Enrollment and individually by School. Evaluation of early education programs.
- v. Discussion on a strategy to partner with our parishes. There is a need to deepen relationships with our parishes. Churches are there to evangelize and Nouvel is to assist in that mission.

- vi. Our Catholic Identity is embedded in each Strategic Goal which is supported. Additional discussions were held on creating a separate domain to emphasize our Catholic Mission guided by HOS and Catholic Mission Committee. Focus on early education on the sacraments. Creating a meaningful, faith journey K-12, for families, and the faculty. Student participation in masses: Altar Serving, Choirs, etc.
- vii. Be ambitious, establish a peer group of institutions that are the best Catholic Schools. Define the vision of excellence.
- viii. Identify opportunities to partner with Diocese & Bishop with Acts 29 and the importance that we have as Catholics to share our faith.
