-78 students interested in enrolling, with 73 new students already enrolled - Strong ninth grade
enrollment approaching 40 students, highest in six years - Both preschool classrooms at capacity

C. Student Ambassador Program - 58 high school ambassadors and 41 junior high ambassadors actively supporting recruitment - Over 24 shadow days conducted this year, a record high - Total enrollment projected to reach 610 for next school year

D. Transportation and After-School Care - Exploring transportation options from Midland to Nouvel -After-school care to be provided at secondary building - New families have already committed after learning of after-school care option
