Offering needs-based tuition assistance is a means of helping families afford a Nouvel education. Through our partnership with FACTS, the aid process will use income, assets, unusual expenses and family size to help determine tuition. After completing the online FACTS application, Nouvel will be able to determine your family's actual tuition cost.



To apply for tuition assistance, please complete the FACTS application online at [www.NouvelCatholic.org/FACTSApplication](http://www.NouvelCatholic.org/FACTSApplication) or by scanning the QR code. Families will complete one application per family and use information from their 2024 Tax Form 1040. A brief statement explaining the request/need for aid will also be required.

We ask all families applying for assistance to complete their FACTS online application by **March 2, 2026**. As stated previously, you do not need to have your 2025 taxes completed in order to apply for tuition assistance. The FACTS application will ask for information from your 2024 tax form.

Each application and corresponding financial analysis provide by FACTS will be reviewed by the Tuition Assistance Committee. Awards are based upon the availability of funding and the number of verified applicants. Families will use either the minimum per student cost of \$3,000 or the determined tuition amount, whichever is higher. Additionally, families that qualify for a multi-student discount and/or St. Gerard Society support will still be able to do so through this process. All Nouvel families are welcome to apply for tuition assistance, regardless of Parish and/or religious affiliation. Unless specifically stated in an endowment document, tuition assistance is awarded annually. For applications submitted by the March 2 deadline, financial aid awards will be communicated via individual emails on or before April 13, 2026.
