**St. Mary of the Immaculate Conception, Greenville (St. Mary's)**  
**Scrip Program Agreement**

**General Terms & Conditions**

St. Mary's sponsors a program called Scrip, where gift cards are purchased at face value, but will generate a rebate that is shared with the purchaser. For example, a family can buy a \$100 Woodman's scrip card for \$100, which is worth \$100 at the checkout. St. Mary receives a 5% rebate from Woodman's, which is shared with the family who purchased the card.

Cards can be purchased with cash, check, or Presto Pay. If using check or Presto Pay, an overdraft fee is charged if the payment is returned for insufficient funds.

The scrip rebates accumulate from June 1<sup>st</sup> to May 31<sup>st</sup> and are distributed annually; the rebates are distributed as follows:

**School or faith formation families** with a fundraising fee will receive 100% of the rebates until the fee is met. After the fee is met, the rebates are split 60% with the family, which is saved as a credit to the school or FF account. **\*\*This is automatically calculated for the family per order, so no special form is needed to designate the rebate to the family fundraising fee or tuition account\*\*** If there are no students enrolled from the family for the next academic or FF year, the rebates will be applied to the parish general fund unless a new form is submitted. The remaining 60% is retained by St. Mary School or Faith Formation (FF), used to offset the cost of the Scrip program and for educational programs at St. Mary.

For school or faith formation families, no further information is needed on this form except signature and date.

**Those without a fundraising fee (i.e., those not taking classes in school or faith formation)**, the rebate is split 60% with the family, and the remaining 40% is applied to the parish general fund. The portion the family receives can be allocated to the beneficiary of your choice, as shown in the below options. More than one group can be chosen for the donation.
