

Mission Statement


The Church of Saint Ann in Lawrenceville,

FISCAL REVIEW

OUTLOOK

Your regular Sunday offering continues to be our primary source of income. It provides the fuel with which we run the parish. This year, our collections have increased significantly by 7.6%, due to a very favorable response to our increased giving campaign last fall. We are grateful to all who responded and especially to those who were able to increase their weekly giving to our parish. Our Finance Committee will be working hard to manage our financial resources, increase revenue and keep us within our budget. Identified givers (those who use envelopes or the automatic withdrawal program) are the largest contributors. They are 29% of our registered parishioners and they contribute 80% of our weekly income. Becoming an identified giver helps us to better serve you, and to quantify your financial contributions to the Church of Saint Ann. It also provides a way for you to publically express your support of our parish. *Please use your* envelopes regularly or join the growing group of parishioners who make their contributions through the automatic withdrawal. This year 90 parishioners made their regular contributions through our automatic withdrawal program contributing about \$10,200 per month. If you have not become an identifiable giver, please consider joining this growing number this year. Even a small amount given regularly will help the parish, and help you strengthen your faith as a good steward. 37% of those who claim to be parishioners have made no identified contribution to our parish this year.

OUR SAINT ANN SCHOOL

Our Saint Ann School is one of our primary parish ministries and represents 11% of our disbursements. (We have included a copy of the School Report.) School enrollment has increased this year to 281. Our school is at 62% capacity. Continuing to increase enrollment is a major challenge for all of us. We are a Nationally Recognized Blue Ribbon School and although the School Marketing Committee continues to do a great job in presenting the good news of our school to the public, word of mouth will always be the greatest encouragement for families to enroll their children. Visit our school; tell your family and friends and neighbors about this great treasure right in our own back vard. We are grateful to all who contribute to our school in many different ways: through volunteer service, gifts, PTA events, and especially those who have stepped forward to contribute to our CEL (Children's Education Lifeline emergency assistance) PROGRAM. This program has allowed families who have met unexpected emergencies continue to keep their children in our school.

CHURCH OPERATION

We continue, through our **Building and Grounds Committee**, to maintain and improve our six properties here in Lawrenceville, and the two properties at our Saint Michael Campus. Preventive maintenance is certainly the most cost effective way of keeping these properties in good working order. This year, expenses were exceptionally high as we replaced the Church roof and gutters, attended to necessary preventive maintenance on our Cross on top of the Church, and repaved the parking lot at Saint Michael Church. The LOOK WHAT WE'VE DONE THIS YEAR! section of this report will help you see how we have been tending to immediate needs, as well as preventive maintenance. As we did last year, we will carefully monitor our income, so we can continue our preventive maintenance without straining our ordinary operating budget.

PARISH MINISTRIES

Our parish ministries continue to expand as we discover more ways

to respond to our mission as a parish. Although the volunteers who serve in these wonderful and diverse ministries provide the backbone of what gets done, each ministry requires support of both personnel and financial resources. Balancing this distribution is a challenging task made easier by your generosity in the Sunday collection. This year, we hired a part time Youth Minister who has already begun to make a real difference to our high school aged parishioners. Next year, for the first time in 16 years, we add the services of a second full time priest to our budget.

FAITH DEVELOPMENT CENTER

Although it is hard sometimes to imagine how we survived without our Faith Development Center, we continue to grow in our understanding of how to best use this great gift to better serve the community. As initial warranties begin to expire, we find ourselves in need of extended service contracts and additional caretaking responsibilities. We are grateful to those who make contributions to our Faith Development Center, and to the Annual Golf Tournament that contributes substantially to this effort as well as those who remember deceased friends and loved ones with a contribution to the Faith Development Center. This building is a source of great pride for our parish, and we need to be good caretakers of this gift. Gradually, we are working to make it an even greater source of religious learning and faith formation.

GOOD STEWARDSHIP

Stewardship is a great responsibility for all of us who are a part of this Church of Saint Ann. It involves serious commitment to use well the gifts of time, talent, and treasure that are given so freely to our community. Each and every parishioner has a responsibility to be a good steward, and to examine their personal stewardship of time, treasure, and talent very carefully. Last October's Increased Giving Campaign brought a very positive response from our parishioners and that increased giving has remained consistent throughout the year. For this we are very grateful. October is the time each year we set aside to challenge all to reflect on their financial giving to our parish, and to consider giving in proportion to the gifts you have received. In these challenging economic times, this type of examination is critical. Generosity, in a time of financial challenge is countercultural, but it helps us move from our self-interest to focus on the common good. Our parish and what we can do, rely heavily on the support that is given by ALL of our members. We ask those who have not been helping with their financial gifts, and are now able to do so, to make a commitment this year. It makes a real difference in what we, as a parish community, are able to do.

MORTGAGE

Like most parishioners, we continue to carry a debt. Before we began building our Faith Development Center, we determined that we would be able to manage that debt without affecting the vitality and mission of our parish. Our mortgage represents about 9% of our yearly expenses. We are committed to continuing to keep this balance while decreasing the principal (\$1,137,280) as of July 1, 2011.

FUTURE EXPENSES

Our Future Project List still contains: enhancing our tabernacle area, providing better storage space for Church, completing the Reception Hall and Kitchen of the Faith Development Center, trimming trees and replacing bushes where needed, and beginning to repaint some areas of the Faith Development Center. At the Saint Michael's campus, we hope to renew the statues inside the Church. We will move ahead on these projects as funds become available.
