

2025 NCJLS ONLINE ENTRY INFORMATION

NCJLS exhibitors must enter online and submit payment at time of entry.

Welcome to ShoWorks! online entry link is <https://nueces.fairwire.com/default.aspx>. This system will be available from September 1 to 5:00 p.m. October 18, 2024.

- Exhibitors must be a member of 4-H, FFA, and/or FCCLA at entry deadline to be eligible to enter. Membership will be verified upon entry deadline. Failure to be an enrolled member will result in disqualification.
- NCJLS exhibitors must take and complete the Quality Counts Test. Exhibitors are required to take the test once per age group. There are three age groups 3rd-5th, 6th-8th, and 9th-12th. The Quality Counts Certificate Number must be entered for each Livestock entry.
- If the exhibitor is competing for Homemaking Sweepstakes Contest (Senior Division exhibitors only), you must type "YES" in the box.
- Dates set aside for corrections are October 19 to 5:00 p.m. November 1, 2024, for corrections. No new entries can be made past October 18. All corrections must be made by calling Show Office at 361.387.5395 or email ncjlsoffice@aol.com. Any entry corrections after November 1, 2024, will be considered late and must be turned into the NCJLS Office with a \$200 late fee per entry. The Show Office is located at 710 East Main Avenue in Robstown.
- Your entry IS NOT complete until you have submitted a copy of your completed W9 IRS Form (if entering an animal – Cattle, Horse, Rabbit, etc.) and payment.

NCJLS ONLINE ENTRY INSTRUCTIONS

- To begin, click "Sign In" in the upper right-hand corner of online entry page.
- Select "Exhibitor" and enter Name, then select "I am a new exhibitor...". Even if you have exhibited in the 2024 NCJLS, all 2025 NCJLS exhibitors must set up new exhibitor information. Click "Continue".
- Enter all your own personal information. Complimentary t-shirt size (YS, YM, YL, AS, etc.) needs to be complete from this window. Exhibitors will enter a personal password, and it is your responsibility to remember your password. Click "Continue".
- Confirm Registration Information. IMPORTANT, verify all personal information is correct (email, phone number, and address are our way of contacting you). Click "Continue".
- Now that your account is open, you can add "Entries." In the Entries screen, choose a Department and then a Division, then click "Add Entry to cart". All livestock entries require a completed W9 Form upload to continue with the online entry process. Continue adding entries.
- Photography Entries. Each exhibitor has an opportunity to enter as many as eight (8) possible entries in the Photography Division. You must submit photos between December 1 – 31, 2024. Entry will be disqualified without a photo upload. For more information, please contact the Show Office at 361.387.5395 or email ncjlsoffice@aol.com.
- After all entries are submitted, click "Continue".
- Additional items include:
 - Four-day car pass (\$20 each)
 - Presale shavings at a discount (\$8 presale, \$10 at show).
 - Additional 90th Anniversary t-shirts. No shirts will be sold past October 18 entry deadline.
 - Click "Continue".
- When you have completed your entry and have reached the confirmation page, sign and submit as directed.
- Payment must be made at time of online entry check out.
- Save your cart so you won't need to start over if you have additional entries to enter later.
- A receipt will be available at check out and emailed to the email address on your information page. Your receipt is your proof of entry.
