Indiana School Choice

Students who are Indiana residents and a member of a household that meets financial eligibility could be eligible for up to and over \$6,000 per student per year.



Over 95% of Families Qualify for an Indiana Choice Scholarship.

School Scholarship (SGO)

We participate in a Scholarship Granting Organization to award scholarships to eligible students. The funding is provided through the generosity of individuals and businesses who provide charitable donations specifically designated to St. Anthony School.



The average student award was \$1,500 in 2024-25.

Pastoral Scholarships

Need based Pastoral Scholarships may be available upon special request for those needing assistance.



Scholarships are offered based on family need.

Parishioner Discount

Registered and active St. Anthony parishioners with students in grades K-8 may receive a discount upon pastor approval via signed affidavit form.

Personal Ways to Fund Student Aid

Private School Deduction

You may be eligible for a \$1,000 state tax deduction based on education expenditures paid for each dependent child who is enrolled in St. Anthony School. Check with your tax accountant for this deduction!

529 Direct Plan

The Indiana CollegeChoice 529 Education Savings Plan may be used to help pay for primary or secondary school tuition. Indiana taxpayers who contribute to a 529 plan can get a state income tax credit equal to 20% of their contributions to a CollegeChoice 529 account, up to \$1,000 per year (\$500 for married filing separately).

How do I apply for student aid?

St. Anthony uses a third-party company called FACTS to evaluate a family's financial situation. Families are required to reapply each year.

Visit FACTS to Get Started

Complete the online Grant & Aid application at online.factsmgt.com/signin/3FFKJ

Upload Supporting Documents

Provide documents to FACTS via upload, fax, or mail. Applications cannot be processed without ALL required supporting documents.

Award Notification

Once ALL supporting documents have been received, it takes approx. 3-4 weeks for a FACTS Grants and Aid application to be processed. You will be notified via email with your student award information and application paperwork.

Enrollment Fees	
A non-refundable enrollment fee of \$200 per child or \$400 per family will be billed to FACTS Payment Plan upon registration. Payment Plan accounts must be set up and activated before enrollment application processing. Enrollments without FACTS setup will be placed on hold. The enrollment fee will only be refunded if St. Anthony School denies admission. Enrollment fees are payable outside of School Choice awards. FACTS: https://online.factsmgt.com/signin/3FFKJ
