CHRISTMAS FLOWER ENVELOPES

Faith Direct does not give us a full report of

It seems useful to provide a brief description of the Order of Readings, at least, for the principal celebration and the different seasons of the liturgical year.

Each Gospel reading has a distinctive theme: the Lord's coming at the end of time (First Sunday of Advent), John the Baptist (Second and Third Sunday of Advent), and the events that prepared immediately for the Lord's birth (Fourth Sunday). The Old Testament readings are prophecies about the Messiah and the Messianic age, especially from the Book of Isaiah. The reading from an Apostle contains exhortations and proclamations, in keeping with the different themes of Advent. December 11, 2022,

Third Sunday of Advent

1st: Isaiah 35:1-6, 10 Psalm 146:6-10 2nd: James 5:7-10 Gospel: Matthew 11:2-11

St. Pius X Church & School Annual Financial Report Fiscal Year Ending June 30, 2022, Commentary

The fiscal year ending June 2022 concluded with positive results for our Parish. As you review the Abbreviated Financial Report on the reverse side of this letter, please make note of the bold lettering for fund drive, depreciation, and endowments. These three accounts must be included in our reporting to the Diocese of Columbus Financial Offices, but do <u>not</u> affect the daily cash operations of the Parish.

The net income for the Church for the fiscal year ending in June 2022 was \$95,337, as reported on our financial statements. This amount included the \$268,410 collected for the capital campaign, which is sent to the Diocese to pay for our original loan and is not included in the cash operations for the Parish. We also must account for the expenses for depreciation of parish properties and the monies received from our Parish endowments. Therefore, our result is a net income for the Parish is \$273,203. We are grateful for our generous parishioners who increased their offertory pledges throughout the year, which averaged \$6,000 - \$8,000 more a month from January through June 2022. We also had an anonymous, one-time donor, who generously contributed \$100,000 to our offertory. As much as we are pleased with this increase in offertory, we continue to experience price increases throughout our campus. We are asking parishioners to consider joining Faith Direct, our online offertory giving program, during our next sign-up weekends, January 7-8, and January 21-22, or increase your current offertory contributions by the method in which you currently contribute. The Parish depends on offertory collections to maintain our programs and operations throughout the campus, and your support helps keep our St. Pius X family strong.

The net loss for the school for this past fiscal year ending June 2022 was \$27,249. This was mainly due to increased utility costs and the financial loss in the school cafeteria. As per the Office of Catholic Schools, the majority of Diocesan school cafeterias, are experiencing a loss within their department at this time. The Diocese and schools are working together to help find resources and a more economical way of operating.

All this information was previously reviewed and approved by our Parish Finance Council, which consists of volunteer parishioners, Father Dave, and Brenda Brammer, Business Manager. If you have a degree in or a background in business finance, and are interested in joining this committee, who meets monthly on the fourth Tuesday, except for the months of May, July and December, please reach out to Brenda Brammer by emailing bbrammer@spxreynoldsburg.com.

St. Pius X Church and School Abbreviated Financial Report Fiscal Year Ending June 30, 2022

CAMINO DE SANTIAGO PRESENTATION


All are invited to an exciting presentation on the Camino de Santiago (the Way of St. James) in Europe. The Camino is a long and ancient pilgrimage route, dating back to the 9th Century, which stretches across Europe, and culminates at the tomb of St. James, the Apostle (whose name is "Santiago" in Spanish), in Santiago de Compostela, Spain. As part of the presentation, Juan and Debra Orellana will share their experience of seeing the Eucharistic miracle that happened in O'Cebreiro, Spain, in the 14th Century. The church of that miracle is located on the way to Santiago de Compostela, along the Camino Frances. During the Power Point presentation, you will be able to see the miraculous presence of the Body and Blood of Christ in the Eucharist, which were physically transformed into actual human muscle/tissue, in an astonishing way. Tradition has it that a weary priest, who had somehow lost his faith in the True Presence of Jesus Christ in the Eucharist, was preparing to celebrate Mass in the little village church, one winter's day. A peasant from a nearby village, having fought his way to the top of the mountain through a fierce snowstorm in order to attend Mass, entered the church just as the priest was beginning the Mass. The priest went on to insult the peasant's devotion and faith and ridiculed him for having come all the way to the top of the mountain in such severe weather to witness what the priest considered a non-existent miracle. The priest then proceeded to rush through the celebration of the Mass, until at the words of Consecration, Christ Himself transformed the bread and wine into literal human flesh and blood. This Eucharistic miracle was confirmed in 1487 by Pope Innocent VIII and is recognized as authentic by the Catholic Church. Besides this miracle, other experiences will be shared throughout the presentation. Juan and Debra just recently became the Coordinators of the Central Ohio Chapter of the American Pilgrims of the Camino and are excited to share their experience with you! The presentation will be held on Sunday, December 11th, starting at 2:00 p.m., in the Msgr. Funk Parish Family Center.



INTRODUCING THE EMMAUS ROAD SCHOLARSHIP FUND

The Office of Catholic Schools recently launched the Emmaus Road Scholarship Fund, a scholarship granting organization (SGO) of the Diocese of Columbus that was formed to capitalize on a new tax credit passed into law by the Ohio Legislature in late 2021. As dictated by Ohio law, the funds raised by the SGO are to be used primarily for academic scholarships for students to attend K-12 schools and prioritized for low-income families. However, ALL students in Our Catholic Schools have the potential to benefit from these scholarship funds.

How does it work? Donors who make a gift to the Emmaus Road Scholarship Fund receive a dollar-for-dollar credit (not a deduction) on their Ohio income tax liability – up to \$750 per person, or \$1,500 if married filing jointly – effectively allowing them to make a choice about how their Ohio tax dollars are utilized. **Donors can restrict their gift for the benefit of one or more schools of their choosing**, or they may direct their dollars to the unrestricted fund which helps the greatest number of students in the diocese. The Emmaus Road Scholarship Fund creates much-needed scholarship dollars for Our Catholic Schools while giving donors the power to put their tax dollars to work to support Catholic education.


