## Time Goes By

One morning in late August I woke up to my 75th birthday. Three quarters of a century marks a milestone for anyone, but especially for me. According to Canon Law, when a bishop turns 75, he must submit his resignation to the Pope.

That afternoon I went to the office, wrote my letter to Pope Francis, and sent it to the Apostolic Nuncio in Washington,

D.C., for delivery to the Holy Father. Until he names my successor, I will quite happily continue to serve as Bishop of Baker. These days I think of myself as "resigned but not retired."

For the Vatican officials who assist the pope in providing bishops for the Church my letter will come as no surprise. From the day of my ordination as bishop in 2012 at age 65, the date of my resignation was foreseeable. That means there has been time to prepare a list of candidates from whom the Holy Father will select a successor.

Nonetheless, I have been advised not to expect the appointment to come soon.

It will not surprise me if a year or two from now I find myself still writing columns for the CHRONICLE! That would be fine with me. I am in no hurry to give up the parish visits that have become the joy of my life.

Another significant resignation occurred this summer in the Diocese of Baker when Father Rick Fischer stepped down as Vicar General in the 46th year of his priesthood. Father Rick knows the diocese well, for he has pastored the faithful in nearly every part of it—Pendleton, La Grande, Baker City, Condon, Burns, Klamath Falls, and Madras. In addition, the US Air Force drew on his priestly skills for several years as well when he served as chaplain in Guantanamo and in the Middle East during Desert Storm.

## El Tiempo Pasa

Una mañana a fines de agosto me desperté para mi cumpleaños 75. Tres cuartos de siglo marcan una etapa para cualquiera, pero especialmente para mí. Según el Derecho Canónico, cuando un obispo cumple 75 años, debe presentar su renuncia al Papa.

Esa tarde fui a la oficina, escribí mi carta al Papa Francisco, y la envié al Nuncio Apostólico en Washington, D.C.,

para envío al Santo Padre. Hasta que él nombre a mi sucesor, con mucho gusto seguiré sirviendo como Obispo de Baker. En estos días me considero "renunciado pero no jubilado".

Para los funcionarios del Vaticano que ayudan al Papa a proporcionar obispos para la Iglesia, mi carta no será una sorpresa. Desde el día de mi ordenación como obispo en 2012 a los 65 años, la fecha de mi renuncia era previsible. Eso significa que ha habido tiempo para preparar una lista de candidatos de entre los cuales el Santo Padre seleccionará un sucesor.

Most important, I could always count on him to tell me what he really thinks, not what I would like him to say.

St. Paul long ago singled out the essential quality to look for in a good Vicar General: that he be "trustworthy." In Father Rick Fischer the Diocese of Baker produced such a priest, a priest who inspires both his bishop and his people to trust him. How grateful we all should be for the gift of his lifelong dedication.

Cuán agradecidos debemos estar todos por el regalo de su dedicación de por vida.

## Positive News for Respect Life Month

In the case "Franciscan Alliance v Becerra," a federal appeals court has affirmed a lower court's decision that the Constitution protects a Catholic healthcare network from a federal requirement to perform gender-changing surgeries and abortions.

Franciscan Alliance, a hospital network founded by the Sisters of St. Francis of Perpetual Adoration, also claimed that the rule violated the Religious Freedom Restoration Act (RFRA) by forcing it to perform abortions and gender-reassignment surgeries inconsistent with its sincerely held religious beliefs.

The Sisters challenged the 2016 mandate, seeking a ruling that protects patients, aligns with current medical research, and ensures doctors aren't forced to violate their religious beliefs and medical judgment.
