



St. Timothy Overseas Project (STOP) 2026 Grant Information

Thank you for your interest in the St. Timothy Overseas Project (STOP). Since 1972, STOP, an initiative of the Church of St. Timothy Social Justice Outreach Committee, has provided funding for human development projects around the world to empower those who are impoverished. STOP is funded by financial gifts from parishioners. In addition to inviting parishioners to donate to STOP, the parish also prays for STOP recipients and parish communications channels provide information about STOP grant recipients and the countries in which they serve.

The Church of St. Timothy in Blaine, Minnesota is a Catholic, Eucharistic community with a strong commitment to charity, social justice, and outreach. This commitment is based in our Catholic belief in the inherent God-given dignity of the human person, the call to solidarity, and the preferential option for the poor. While our commitment is rooted in faith, projects do not need to be faith based to be considered.

Between one and three projects are funded each year, depending on the number of proposals received. Please note that STOP generally does not fund a project in the same geographical location two years in a row. In 2025, STOP grant locations were in El Salvador, Ghana and Zimbabwe. STOP grants range from \$2,000 to \$5,000.

Projects funded may include, but are not limited to

- Buildings such as churches, schools, and pastoral centers that provide gathering places for education and community building. Buildings will only be funded to supplement a primary self-help project; the major emphasis in project proposals should be placed upon programmatic needs.
- Water projects such as digging, maintaining, and/or improving wells or irrigation systems.
- Equipment such as tractors, water pumps, generators, and vehicles that support a primary self-help project.

In order to be eligible for application, projects must meet the following criteria

- Organizations must be tax exempt under section 501(c)(3) of the Internal Revenue Code and must provide proof of this status with the application.
- Organizations must have a United States contact.
- Organizations must have a United States bank account directly connected to them.

Please respond to the prompts on the following application in a separate document. All pieces of the application must be submitted by December 31, 2025 to be eligible for consideration. Completed applications should be submitted to
