



DOUBLE YOUR DONATION WITH A MATCHING GIFT

DID YOU KNOW that many employers sponsor matching gift programs and will match charitable contributions made by their employees? Some even match to gifts made by retirees. Every company has its own process and restrictions, but follow these basic steps to learn if your contribution can be matched.

- 1) Find out if your company has a matching gift program.** You can start by reviewing the companies listed on the reverse side or search your company name at www.matchinggifts.com/diometuchen.
- 2) Contact your Employer's Human Resources Office** for specific details on your company's process. Most employers are now requiring electronic applications and may limit eligibility to religious organizations but will match to charitable or educational entities, such as our Catholic Charities, Foundation for Catholic Education or our Catholic high schools. (Our Tax ID numbers are listed below.)
- 3) Apply for the matching grant by registering your gift with your company.** (Note: the donor must initiate the process.) Most companies will assign a Gift ID number to your request and will send an email to both you and the Diocese. Your company will ask us to verify the amount of your gift. Once your gift is confirmed, your company will decide if your gift is eligible for a match based on your company's requirements.
- 4) If you need a receipt for your gift or a Letter of Acknowledgement,** please contact us at 732.562.2432 or email development@diometuchen.org.
- 5) Once received, you will be soft-credited for the company match** and your parish will receive credit toward your parish's Bishop's Annual Appeal Goal.
