3. **Applications that are incomplete will not be accepted without notice.**

4. Applications sent via E-mail or fax is acceptable. The Certificate of Suitability, required after your notice of inclusion to the program **must** be sent through regular postal mail, which needs to bear the original seal of the (Arch)Diocese endorsing your missionary group.

5. The Office of Pontifical Mission Societies does not have the ability to wire transfer funds to any diocese or religious community completing the mission cooperation program. **It is necessary that funds be sent via check to the United States representative.**

6. Due to the overwhelming requests for participation in the Missionary Cooperation Plan, applicants chosen for a given year will ordinarily not be considered for inclusion for the next five (5) years, **unless willing to participate in the Missionary Childhood Association's Council on Mission Education (COME), which will require you to visit a number of our schools and/or Parish Religious Education (3-4) and present to the students about missionary work in general.**
