### FROM THE PASTOR

### **ELEVATOR PITCH**

An "elevator pitch" is a succinct speech highlighting the value of an idea, commodity, or event. Imagine sharing a brief elevator ride with someone rich or powerful enough to change the world. What would you pitch? You may never ride that elevator, but practicing your elevator pitch improves you: It focuses you on your priorities and refines your thoughts and words in preparation for future opportunities.



So followers of the Lord Jesus might consider their "elevator" profession of faith. It's hard to imagine anyone wanting to hear a brief statement of your faith, out of the context of your life and family and community. But working on it anyway can improve *you* as a follower of Jesus, because it focuses you and opens your mind and heart more widely to the Spirit.

For the past two weeks, I've been writing bulletin articles meant to move you to elevator-pitch articulations of your Christian faith:

- How does Jesus free you from guilt for your offenses against God and others?
- How does the Lord Jesus make up for your past failures to do or become what you should?
- How is Jesus moving you to love others more profoundly?
- How does Jesus invite you to share his life in the Church or in the Holy Trinity?
- How do you see Jesus saving your community through the promise of justice and judgment?

Don't indulge yourself by thinking long, circuitous thoughts about how you might answer these questions. That'd be a little like thinking hard about exercising: It misses the point! Instead, write out a one- or two-sentence answer to each question. And if you can't do it—well, *then* you have some hard thinking to do.

- Please note that instead of a fall rummage sale, we're hosting a bundle drive for the St. Vincent de Paul Society. Donate clothing, household items, and small (working!) appliances October 29 and 30. Load them right onto the truck in the parking lot! Your donations fund the SVdP Society and its good works on behalf of needy families.
- All Saint's Day, November 1, is a holy day of obligation. The special Mass schedule will be posted in next week's bulletin. Alongside your Hallowe'en celebrations, please attend a Mass celebrating the victory of the Lord in so many of our brothers and sisters.
- The following day, November 2, is All Souls' Day. That morning, after the 8:00 a.m. Mass, we'll drive to St. Ignatius & St. Mary Cemeteries to pray for those buried in our parish cemeteries and for all the dead. That evening, at 6:30 p.m., we'll celebrate our annual Mass for all the dead, naming especially those of our community who died in the past year. All are welcome to both observances.


### GIVING TO YOUR PARISH


As you plan your giving for 2016 consider that there are ways to make revocable or irrevocable planned and deferred gifts to the parish in addition to outright cash. Here are some options to consider.

### How to Initiate a Tax Free Gift from Your IRA if You Are Over 70½ Years of Age

- Call your IRA fund custodian/investor/broker.
- He/she may have a form for you to sign giving instructions regarding the charity(s) you wish to receive gifts and when you wish to make these donations from your IRA.





- The charity/parish/diocese will send a special letter of acknowledgement to the donor indicating
  that the gift from the IRA was received and the date it was received. This will verify that the gift
  should not be claimed as taxable income.
- Your broker/fund custodian/investor may have other instructions for you. You may not claim an
  income tax deduction for this type of gift.

### 10 Ways to use planned qifts for Our Campaign for the Church Alive! pledge payments or new qifts

1. Use <u>cash</u>; 2. Use an <u>IRA charitable rollover</u>. Have check made payable to Our Campaign for the Church Alive! (see above); 3. Appreciated securities (<u>stock</u>) (see below); 4. Make a charitable provision in your <u>Will</u> (see below) (cannot be credited toward your parish goal); 5. A <u>Charitable Gift Annuity</u> helps the campaign and provides you with income for life; 6. A <u>Charitable Lead Trust</u> may be ideal for six figure gifts, helping the Church now, and your family later; 7. <u>Charitable Remainder Trusts</u> are also great possibilities; 8. Don't forget about using a <u>life insurance policy</u>; 9. Your <u>retirement fund</u> may generate a gift, either during life or after your lifetime; 10. With the <u>Gift Annuity Enhancement</u> program you can make an immediate gift and receive income for life in the process.

### Compare: A Bequest through your Will vs. a Charitable Gift Annuity

Say you make a provision in your Will to benefit your parish. But if you use up your assets (nursing home, etc.) there may be nothing remaining to benefit anyone, including your parish. One option is to create a Charitable Gift Annuity now. These funds will be immediately removed from your estate. The annuity will guarantee mostly tax-free income for you (and possibly a second annuitant) for as long as you live. You will also receive an immediate income tax deduction. Capital gains tax savings result if you use appreciated securities to fund the gift annuity. After your death, the remainder of your gift annuity will go to help your parish. 50% of the value of your gift annuity may count toward a pledge made to "Our Campaign for the Church Alive!" For a free prospectus, call (412) 456-3055.

### **Gifts of Stock Eliminate Capital Gains Tax**

A gift of appreciated securities (stock) can provide you with a significant income tax deduction. You may receive an income tax deduction of up to 30% of your adjusted gross income, and will not be required to pay capital gains tax in the process. Larger deductions may be carried over for five additional years.

Instruct your attorney to make a provision in your will or living trust using this language: "I give, dev	vise
and bequeath \$ [specify dollar amount] [or % percentage of my estate] [or%	
percentage of the remainder of my estate or property] to Parish at [include legal address of	you
parish or school].

Our Gospel readings both this week and next week lend themselves to an understanding of God's desires for us to help the poor. Our reading from the Gospel of Luke today (October 23) tells us that the tax collector's prayer allows God to be God and so allows God to pour mercy into his heart. When we pray and give alms to the poor, we allow God's mercy to be poured into their hearts:

### SECOND COLLECTION ON OCTOBER 30 TO BE SPLIT

A letter to Fr. Dave from the Very Reverend Lawrence DiNardo, Vicar General/General Secretary of the Diocese of Pittsburgh:

October 14, 2016

Last week Hurricane Matthew ravaged the Caribbean and southeast United States with torrential rain and damaging winds. While our own country has been affected by flooding, the destruction in Haiti is much worse. Reports indicate that nearly 900 people have died in Haiti alone and tens of thousands of homes have been destroyed throughout the Caribbean. Support will certainly be needed to help rebuild homes. However, food, water, and hygiene products are the most immediate needs so that those who have been displaced can be nourished and the spread of disease be minimized.

Catholic Relief Services is already providing direct aid throughout the Caribbean, but especially in Haiti. The Most Reverend Joseph E. Kurtz, President of the United States Conference of Catholic Bishops has asked each diocese to take up a second collection to aid the victims of Hurricane Matthew. I am asking that you take up a special collection the weekend of October 29-30, 2016 that would go towards the work of Catholic Charities in the United States and Catholic Relief Services in the Caribbean.

Thank you for your consideration as we seek to assist our brothers and sisters in need. May we continue to pray for all who are suffering because of this tragedy and may God give rest to those who have died.

Of course we'll help! But this means that our second collection next week will be split. Since our St. Vincent de Paul 5th Sunday Collection was already planned (and needed) we will be dividing our gifts to provide aide to those in Haiti *and* Carnegie! Please be generous. ### Know the Positions of the Presidential Candidates

In keeping with its mission, the Pennsylvania Catholic Conference (PCC) aims to educate and inform Catholics about a wide range of issues. The information listed here has been compiled from policies, public statements, official and campaign websites and other resources to help voters form their consciences before entering the voting booth. The issues that appear here do not represent a complete list of issues that may be of importance to Catholics. The PCC neither supports nor opposes any candidate for public office.

Any politics of human dignity must seriously address issues of racism, poverty, hunger, employment, education, housing, and health care. Therefore, Catholics should eagerly involve themselves as advocates for the weak and marginalized in all these areas...But being 'right' in such matters can never excuse a wrong choice regarding direct attacks on innocent human life. Indeed, the failure to protect and defend life in its most vulnerable stages renders suspect any claims to the 'rightness' of positions in other matters affecting the poorest and least powerful of the human community. If we understand the human person as the 'temple of the Holy Spirit' -- the living house of God -- then these latter issues fall logically into place as the crossbeams and walls of that house. All direct attacks on innocent human life, such as abortion and euthanasia, strike at the house's foundation. These directly and immediately violate the human person's most fundamental right -- the right to life. -- From Living the Gospel of Life, No. 22 with original emphasis (Pastoral Statement of the U.S. Catholic Bishops, 1998).

### **ABORTION**

"I believe we need to protect access to safe and legal abortion, not just in principle but in practice," <u>Clinton said</u> at a rally in January.

<u>Clinton supports</u> the repeal of the Hyde Amendment and the <u>Democratic Party Platform</u> states, "We will continue to oppose—and seek to overturn—federal and state laws and policies that impede a woman's access to abortion, including by repealing the Hyde Amendment." The Hyde Amendment restricts the use of federal funds to pay for abortions.

While Trump previously described himself as "pro-choice," in August 2015 <u>Trump said</u> he has "very much evolved" on the issue of abortion and "I am pro-life." <u>He said</u> he supports exceptions in the case of rape, incest and when the life of the mother is at risk.

No statement by Trump on the Hyde Amendment could be found, but the <u>Republican Party Platform</u> calls for "codification" of the Hyde Amendment, "We call for a permanent ban on federal funding and subsidies for abortion and healthcare plans that include abortion coverage."

### DEATH PENALTY

During a February 2016 debate, <u>Clinton said</u> regarding the death penalty, "I do for very limited, particularly heinous crimes, believe it is an appropriate punishment, but I deeply disagree with the way that too many states still are implementing it."

In 2011, <u>Trump said</u> he is "very much in favor of the death penalty."

### DOCTOR PRESCRIBED SUICIDE

During a February Town Hall Meeting, <u>Clinton said</u> doctor prescribed suicide "is a crucial issue that people deserve to understand from their own ethical, religious, faith-based perspective...I want as president to try to catalyze that debate." The <u>Democratic Party Platform</u> makes no mention of doctor prescribed suicide.

No statement by Trump on this issue could be found, but the <u>Republican Party Platform</u> states, "We oppose euthanasia and assisted suicide."

### FDUCATIONAL CHOICE

In 2007, <u>Clinton said</u>, "I'll tell you why I won't support vouchers. Number one, I don't think they're constitutional. But number two, I don't see how you would implement them without having a lot of people get vouchers for schools that would be teaching things antithetical to American values." In his book *The America We Deserve* (2000), <u>Trump wrote</u>, "we've got to bring on the competition—open the schoolhouse doors and let parents choose the best school for their children. Education reformers call this school choice, charter schools, vouchers, even opportunity scholarships. I call it competition—the American way."

### **HILLARY CLINTON**

### **DONALD TRUMP**

### Environmental responsibility

Clinton's campaign <u>website</u> states that her energy "plan is designed to deliver on the pledge President Obama made at the Paris climate conference" where over 190 countries agreed to reduce global greenhouse gas emissions and meet existing financial commitments to an international climate fund.

During a May 2016 policy address on energy, <u>Trump said</u> that in his first 100 days in office, "We're going to cancel the Paris Climate Agreement and stop all payments of U.S. tax dollars to U.N. global warming programs."

### FREEDOM OF RELIGION

Clinton described the First Amendment Defense Act as "taxpayer-funded discrimination by those who cite religion as a reason to deny services to LGBT people nationwide." The First Amendment Defense Act would protect against adverse federal actions directed toward individuals and organizations whose religious beliefs and moral convictions indicate that marriage is between one man and one woman.

In a December 2015 letter <u>Trump wrote</u>, "If Congress considers the First Amendment Defense Act a priority, then I will do all I can to make sure it comes to my desk for signature and enactment."

### HEALTH CARE ACCESS FOR THE UNINSURED

According to <a href="here">her website</a>, Clinton will "defend the Affordable Care Act and build on it to slow the growth of out-of-pocket costs." Her plan would also provide health insurance for the lowest-income Americans by incentivizing states to expand Medicaid, and make enrollment through Medicaid and the Affordable Care Act easier.

According to <a href="his-mediately-deliver">his-mediately-deliver</a> a full repeal of Obamacare." He also said, "As we allow the free market to provide insurance coverage opportunities to companies and individuals, we must also make sure that no one slips through the cracks simply because they cannot afford insurance. We must review basic options for Medicaid and work with states to ensure that those who want healthcare coverage can have it."

### IMMIGRATION

According to <a href="her-website">her-website</a>, Clinton will "introduce comprehensive immigration reform with a pathway to full and equal citizenship within her first 100 days in office." She will "defend President Obama's executive actions" to provide deportation relief for DREAMers and parents of citizens and lawful residents; "end family detention and close private immigrant detention centers" and "promote naturalization."

According to <u>his website</u>, Trump will build a wall across the southern border, paid for by Mexico. To defend the immigration laws, Trump proposes to triple the number of ICE officers (currently 5,000); create a nationwide e-verify to "protect jobs for unemployed Americans"; return "criminal aliens" to their home countries; detain "illegal aliens" at the border until they are returned to their home countries; defund "sanctuary cities"; enhance penalties for overstaying a visa; cooperate with local gang task forces and end birthright citizenship.

### INTERNATIONAL SECURITY

According to <a href="https://example.com/http

<u>Trump said</u> he would bring about the defeat of ISIS by destroying the source of its funding, oil and banks that funnel money to the organization, "take the oil...the oil that ISIS is pumping, where they're getting tremendous amounts of revenue. I've said, hit the banking channels. You know, they have very sophisticated banking channels... they're taking in tremendous amounts of money from banking channels."

### Marriage

In response to the Supreme Court's decision to strike down state laws defining marriage as between one man and one women, <u>Clinton</u> tweeted, "Proud to celebrate a historic victory for marriage equality."

In 2015, Trump said, "I'm (for) traditional marriage."

### POVERTY

In 2013 while members of Congress were debating the details of the Farm Bill, Clinton tweeted, "What happens to kids in families cut from unemployment insurance & food stamps? They're #2SmallToFail, & deserve an equal chance to succeed."

In a June 2015 interview, <u>Trump said</u>, "We have to create incentives that they actually do much better by working. Right now, they have a disincentive. They have an incentive not to work." When asked if he would insist people work for food stamps and other welfare assistance, Trump said, "Well, you could - you could start looking at things like that... The problem we have right now, we have a society that sits back and says we're not going to do anything. And eventually the 50 percent cannot carry, and it's unfair to them, but cannot carry the other 50 percent."

### REFUGEES DISPLACED BY TERRORISM

Clinton said the U.S. should do more to help Syrian refugees, "We're facing the worst refugee crisis since the end of World War II...I think the United States has to do more, and I'd like to see us move from what is a good start with 10,000 to 65,000 [refugees permitted in the U.S.]."

<u>Trump said</u> regarding refugees, "It is a very, very disturbing thing that's going on in Europe. And we're going to have it over here, too. And they just can't do what they're doing... We're not going to keep them here. They're going back."




