## 1m. Cash Receipts

Proper internal controls should be in place for cash handling. Whenever possible, receipt of cash should be directed to the parish or school business office. At least two persons should be involved in cash handling. The funds should be maintained in a secure (locked) location on parish or school grounds. Tamper proof bags are strongly encouraged.
