| As always, please consult your tax advisor for professional advice for your individual tax situation. The tax law for grain donations is very complex and there are specific criteria that must be met. | | | | |
| A representative from MLTF will open an account with the elevator in anticipation of the grain donation. Please contact us in advance so that an account can be established prior to delivery. | | | | |
| • The farmer must deliver grain to the elevator or currently hold unpriced grain in their name to provide proof of production. (Please note that contracted grain sales will not be accepted as a grain donation.) | | | | |
| The farmer must transfer ownership title of the commodity to MLTF. | | | | |
| The MLTF staff must authorize the sale of the grain. | | | | |
