

## Diocese of Sioux City Scholarship Program Frequently Asked Questions for Parents

<b>How is income eligibility determined?</b>	Your income determines if you are eligible for the Diocese of Sioux City Scholarship Program. To qualify for the diocesan scholarship programs TADS will look at your <b>Federal Taxable Income</b> on your most current tax return.

<b>How many students are funded by Diocesan tuition scholarships?</b>	Last year 2,941 students received scholarships ranging from \$250.00 to \$3,205.00																				
<b>Is there any other criteria to qualify?</b>	To qualify for a MLTF scholarship the family must be an Iowa resident. MLTF will award to students age 5 by Sept. 15 if they meet income and residency requirements. This includes transitional, optional or alternate kindergarten. To qualify for a Birzle scholarship the student must be in grades 9-12.																				
<b>Do my taxes need to be completed prior to applying?</b>	No, The application itself that is due May 1st can be submitted before you complete your tax return. Any questions regarding expenses/income can be estimates.																				
<b>How do I apply for a tuition scholarship?</b>	The Diocese of Sioux City Scholarship Program applications must be submitted online. The online application link is available on your local school's website and can be found at: <a href="http://www.scdiocese.org/scholarship">www.scdiocese.org/scholarship</a> Please contact your local school if you need assistance.																				
<b>What if I don't have internet access to complete an online application?</b>	Parents can contact their local school for an individual appointment to use the school's internet access to complete an online application. Parents must submit their Federal Form 1040 from the previous year and other required supporting documentation as requested by TADS.																				
<b>Do I need an email address to complete the online application?</b>	Since all notifications about missing/incomplete materials are by email you are strongly encouraged to provide it and monitor it for communications from TADS.																				
<b>When is the application open?</b>	The online application is open beginning January 30th. The application is available in English and Spanish.																				
<b>Do I need to fill out an application for each of my children?</b>	No, only one application per household is required. Be sure to include all children on this application.																				
<b>When are applications due? When will be notified?</b>	<p><b>Application due May 1st</b></p> <p>Emails sent to parents by June 1st</p> <p>Enrollment verified by schools in early September</p> <p>Funds sent to schools in mid-October</p>																				
<b>Do Foreign Exchange students qualify?</b>	Residence in Iowa is temporary for foreign exchange students therefore they would not qualify for any Diocesan assistance.																				
<b>How should divorced parents apply?</b>	In the case of divorced parents the tuition responsibility of each parent should be indicated on the application. (ex: 50-50 split on tuition then award is based on 50% of tuition). A scholarship awarded to one parent cannot be shared between the parents. If divorced parents each pay a portion of the tuition bill, then each household needs to complete an application for a possible scholarship towards their portion of tuition.																				
<b>How should guardians apply?</b>	Applications for students residing with a grandparent or guardian should be filled out by the individual who claims the student(s) on the tax return. TADS will use that tax return to determine eligibility and need.

**Frequently Asked Questions for Parents**

<b>How should foster parents apply?</b>	Families with foster children in their home should complete a separate application with just the foster children listed on it. Any income such as state subsidies should be included; however, no expenses need to be listed. The application should exclude all financial information of the parents and the foster parents.
<b>What if the application fee is cost prohibitive for my family?</b>	If the application fee is cost prohibitive, you are encouraged to contact the school to request that they pay the fee on your behalf.
<b>Are special financial circumstances considered?</b>	Families experiencing a hardship are asked to provide information in the supplemental questions. The individual scholarship amounts as recommended by TADS cannot be altered by Diocesan staff or school representatives due to financial hardships. However, the school's local tuition assistance committee may consider special circumstances for their local awards.
<b>What if parents were not required to file taxes?</b>	Those families who were not required to file taxes will note that on the application. Copies of all supporting documentation for household non-taxable income such as Social Security income, Child support, Food stamps, Workers' compensation, and Temporary Assistance for Needy Families (TANF) are required to be submitted. A notarized Non-filer form(VNF) will also be required and must be signed by a school administrator.
<b>What if I have questions about how to complete the application?</b>	TADS is happy to assist families with questions about completing their applications. The TADS call center is open Monday-Friday from 7:00am - 5:00pm at 800-477-8237. The TADS online application also has a chat feature that is available. You can also contact your school for additional assistance.
<b>Is the Diocese of Sioux City Scholarship Program the only assistance available?</b>	Many schools have local assistance programs in addition to the Diocese of Sioux City Scholarship Program awards. Generally families must first complete an application with TADS as a prerequisite to applying for local assistance. Local assistance programs, however, can create their own eligibility guidelines or consideration of special circumstances.
<b>What if the award my family receives is not enough?</b>	Scholarships made by the Diocese of Sioux City Scholarship Program cannot be appealed as the income guidelines are set by state law and the proportion of funds available for each family is based on the overall need of qualifying applicants. If you feel you need additional funds to supplement your scholarship, you are strongly encouraged to contact your local school/parish about local assistance programs and any other opportunities for assistance.
<b>Can an application be withdrawn?</b>	Applicants who choose to withdraw their application for a scholarship must communicate directly with TADS their decision to withdraw. Neither school representatives or Diocesan staff can make this request.
<b>Will TADS take ESA payments into consideration when awarding?</b>	TADS will presume all Iowa residents will receive an ESA and that will be a factor when determining need.
