• Principals Report:

- o Cameras have arrived they work well, indoor and outdoor, can see license plates outside.
- Middle School is going virtual for 5 days due to lack of teachers.
- Masks are staying for now. Teachers must show proof of vaccination or require testing, per government guidelines.
- Personnel Issue A new technology teacher is being searched for.
- Virtues in Practice The monthly virtue for January is Gratitude.
- Outreach We sent Thanksgiving and Christmas mailings out to the homebound at both St. John Fisher and St. Veronica Parish.
- EANS check for \$43k arrived.
- Wifi points have arrived.
- Open House Will be on Jan 30. We put an ad in the telegraph, ordered yard signs, and let parents and parishioners know. We are looking at taking reservations as well as walk-ins. Reaching out to parents, will provide lunch for teachers.
- Registrations for current families should be going out this week.
- Safety needs: 30 walkie-talkies and FCC license approx. \$11,000.
- Auxiliary money lower than in the past due to enrollment, some specialists may need reduced hours to make up for loss of funds. These are all contracted through West Clermont and salaries for these positions/nurses are paid from those funds. EANS funds helped keep these positions this year.
- State of Ohio still requiring a sub license. Lack of teachers and aids continue.
- Staffing for cafeteria monitor, etc. still needed.
