4.	<u>Tuition Payment Option</u> - Tuition payments are due on your selected due date, with a grace period of 5 calendar days. You may select one of three options for your payment transfer when you set up your FACTS payment plan. All late charges are posted by FACTS on the 21 <sup>st</sup> of each month. 5.	<u>Delinquent Tuition</u> – If no payment or correspondence has been received within 5 calendar days of your due date, a \$30.00 late fee will be applied to <b>EACH</b> delinquent month. Delinquent accounts will receive a past due invoice sent via email by FACTS and a \$30 late fee will be assessed to the account. The parent or guardian is required to contact the finance office to discuss payment. If an unpaid balance is <b>over 30 days in arrears</b> (resulting in a delinquent account), student(s) will not be allowed to participate in field trips or may be excluded from class until the account is current. Eighth grade students will not be allowed to participate in end of the year activities or graduation exercises.
