### FREQUENTLY ASKED QUESTIONS

### What is the mission of the Catholic Foundation for Greater Pittsburgh (CFGPitt)?

As an independent, nonprofit foundation, the CFGPitt is committed to growing philanthropy according to the teachings of Jesus Christ. The CFGPitt promotes charitable giving to sustain the legacy of the Church by serving our sisters and brothers and addressing the needs of the community for generations to follow.

# How is the Foundation different from an annual offertory or capital campaign?

A gift to the Foundation is different from an annual offertory or capital campaign in purpose and impact:

**Annual Offertory** supports the day-to-day operations of your parish like utilities, staff salaries, and liturgical needs.

**Capital Campaigns** fund specific, time-bound projects such as building renovations or new facilities.

A gift to a **Foundation Endowment** is a long-term investment. It's preserved and grown over time, with just a portion spent annually supporting ministries, parishes, schools, or causes you choose. It's the difference between giving for today and giving for generations to follow.

#### Can I direct how my gift is used?

Yes, you can absolutely direct your gift. At the Foundation, we welcome designated gifts whether you want to support Catholic education, vocations, parish life, or a specific ministry close to your heart. We'll work with you to ensure your gift honors your intentions and makes a lasting impact in the area you care about most.

#### How does the CFGPitt support my parish?

Each parish has an endowment fund within the Foundation. This fund directly supports the parish in perpetuity and ensures ongoing support to be used at the discretion of the parish.

## Why should I give to the Foundation instead of directly to my parish?

Both gifts to the Foundation and direct gifts to your parish are impactful. Discussing your intentions with your pastor and the Foundation staff can help you determine the best giving destination based on your desired impact.

Foundation Gifts: Gifts to the Foundation, especially through endowment funds, are designed to grow over time, ensuring a lasting source of income.

**Parish Gifts:** Direct gifts to your parish may have a more immediate impact, addressing current needs and projects.

#### Are gifts to the CFGPitt tax-deductible?
